- 2. The above candidates are directed to undergo training for 30 weeks as per schedule enclosed at Annexure-A, failing which this acceptance will stand cancelled. These candidates shall also take training from an Executive Magistrate to be nominated by the Collector concerned to acquire sufficient knowledge of criminal law and procedure for a period of two months alongwith revenue training.
