NOTIFICATION

The Governor, Himachal Pradesh on the recommendations of the Departmental Promotion Committee and in consultation with HP Public Service Commission, is pleased to accept the following officials as B-Class Tehsildar candidates in the pay band of Rs. 10,300-34,800+5,000 Grade Pay, with immediate effect:-

2. The above candidates are directed to undergo training for one year i.e. 6 months Settlement and 6 months Revenue training as per schedule enclosed at Annexure-A, failing which this acceptance will stand cancelled. These candidates shall also take training from an Executive Magistrate to be nominated by the Collector concerned to acquire sufficient knowledge of criminal law and procedure for a period of two months alongwith revenue training. If, on expiry of the prescribed training, performance of any of the candidates is found unsatisfactory the period of training shall be liable to be extended further.

3. The salary of the above candidates will be drawn against the substantive post of feeder category till the completion of requisite training. Their lien will be retained in the feeder category for two years and extendable for one more year.

4. The Additional Chief Secretary-cum-F.C. (Revenue) to the Government of Himachal Pradesh shall be at liberty to cancel the candidature of the above mentioned candidates at any time and they will be reverted to the lower posts, if:-

- A) He does not show proper interest in the matter of receiving practical training.
(b) There is any other reason/cause considered fit for taking such action by the Additional Chief Secretary -cum- Financial Commissioner (Revenue).
