Subject:- General Election to Lok Sabha-2024 and Bye-elections to Legislative Assmbly of Himachal Pradesh, 2024-Grant of Paid Holiday to Employees on day of poll-Reg.

Sir/Madam,

I am directed to bring it to your notice that General Elections to the Lok Sabha-2024 and Bye-elections to Legislative Assembly of Himachal Pradesh are scheduled to be held on 01.06.2024.

In this regard, your attention is drawn to the provision of Section 135-B of Representation of the People Act, 1951. For your ready reference the provision of Section 135-B, is as under:-

"135-B Grant of paid holiday to employees on the day of poll- (I) Every person employed in any business, trade, Industrial undertaking or any other establishment and entitled to vote at an election to the House of the People or the Legislative Assembly of a State shall, on the day of poll, be granted a holiday.

- (2) No deduction or abatement of the wages of any such person shall be made on account of holiday having being granted in accordance with sub section (I) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless be paid for such day the wages he would have drawn had not a holiday been granted to him on that day.
- (3) If an employer contravenes the provisions of sub section (I) or sub section (2), then such employer shall be punishable with fine which may extend to five Hundred Rupees.
- (4) This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged."

Further, there shall be a special paid holiday on **01**<sup>st</sup> **June**, **2024 (Saturday)**, which is poll day for the registered voters of State of Punjab working in the border areas of Una, Kangra, Chamba and Solan District of Himachal Pradesh, on account of Punjab General Election to Lok Sabha-2024.

Further, there shall be a special paid holiday on 19<sup>th</sup> April, 2024 (Friday), which is poll day for the registered voters of Jammu & Kashimr, UT working in the border areas of Lahaul-Spiti and Chamba Districts of Himachal Pradesh, which are adjoining Jammu & Kashmir, on account of Jammu & Kashmir General Election to Lok Sabha-2024.

Further, there shall be a special paid holiday on 25<sup>th</sup> May, 2024 (Saturday), which is poll day for the registered voters of State of Haryana working in the border areas of Sirmour & Solan Districts of Himachal Pradesh, on account of Haryana General Election to Lok Sabha-2024.

Further, there shall be a special paid holiday on 19<sup>th</sup> April, 2024 (Friday), which is poll day for the registered voters of State of Uttrakhand working in the border areas of Sirmour & Shimla Districts of Himachal Pradesh, on account of Uttarakhand General Election to Lok Sabha-2024.

Further, there shall be a special paid holiday on 19<sup>th</sup> April, 2024 (Friday), which is poll day for the registered voters of State of Uttar Pradesh working in the border areas of Himachal Pradesh, on account of Uttar Pradesh General Election to Lok Sabha-2024.

Further, there shall be a special paid holiday on 20<sup>th</sup> May, 2024 (Monday), which is poll day for the registered voters of State of Ladakh working in the border areas of Himachal Pradesh, on account of Ladakh General Election to Lok Sabha-2024.

You are, therefore, directed to bring the said provisions to the notice of occupiers/managers/owners of factories/Industrial establishments, shops and other commercial establishments situated in the State of Himachal Pradesh and direct them to grant additional / special paid holiday to the employees / workers working in their factories/establishments situated in Himachal Pradesh as per section 135-B of Act ibid on scheduled dates in order to exercise their right of franchise.

Special paid holiday will be applicable to all the employees working in factories/Industrial establishments, shops and other commercial establishments situated in the State of Himachal Pradesh who are registered voters of above mentioned States/UT.

It is however, clarified that special casual leave may be given to those employees who are working in different places in the State



but have right to vote in other constituencies/places in the Pradesh on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/her vote. It is further clarified that above paid holiday's may be given to such employees, only on the production of certificate of the concerned Presiding Officer that the employee has actually cast his/her vote.
