RTA Decision: RTA after detailed discussion on each case and discussion with all the applicants present in the meeting found that these 29 auto-rickshaws are plying under self-employment scheme and non-renewal of these permits will lead to unemployment among these permit holders. After detailed deliberation on this issue, it was decided to renew all these 29 auto-rickshaw permits in existing fuel only subject to payment of all due taxes/fees and payment of penal amount @ Rs. 2,000/- per annum for each delayed year. The Secretary, RTA Kullu and MVI Kullu will verify the existence and fitness of these Auto-rickshaws jointly. RTA further decided that in case, the above mentioned 29 auto rickshaws are not found in existence or fit for plying on the road, then these auto rickshaw permits shall be replaced with Electric Auto/CNG only as per decision of the STA dated 26.06.2024. RTA further decided that if it is found at any stage that any information was withheld and/or permit was got renewed by misrepresenting the facts or by fraud, the same shall be liable to be dealt with in accordance with the provisions of Section-86 of the Motor Vehicles Act, 1988 and rules made thereunder.

The RTA considered these applications and after examining these applications on the basis of information available on frequency of buses on various routes in the district, model/manufacturing year of stage carriage bus, no. of new route permits sanctioned, flow of vehicular movement/traffic increase on the road, bus fleet with the operators and financial implications of reduction on seating capacities, road safety issues regarding replacement of old buses with new BS-VI norms buses and to provide environmental friendly and better bus service facility to the public in the district. RTA decided these applications as per the decision given in remarks column against each case, subject to the following conditions as circulated vide letter No. STA/Meeting/24.02.2020/1-2020-10855740 dated 20.08.2020:-

1. The replacement is allowed for new or stage carriage buses upto 12 years old from the date of its registration.
2. The replacement is allowed between Bonafide Himachalis only.

The following cases are placed before the RTA for consideration/order in the light of instruction issued on dated 20-05-2022 please:

Sr. No.	<p>Detail of the case :- Sh. Gulshan Kumar sold his bus HP33C-0775 on dated 02/12/2014 which was entered in the route Permit No. 264/RTA/K/2008 which was valid till 12/02/2018. The applicant requested for the replacement of the vehicle on dated 05-02-2015 and the replacement permission had been issued to the applicant by this office letter No. RTA (K) Stage Carriage/HP33C-0775/3135 dated 19-02-2015 with the condition that the owner of the vehicle shall be produce new bus within three months on or before 04-05-2015. But the applicant failed to produce new bus during the stipulated period. The applicant had produced the documents of another bus bearing registration No. HP33D-0775 10th July 2015 after the lapse of about 8 months of selling the previous vehicle; this matter was to be placed before the RTA meeting for consideration for approval. But during the period the bus number HP33D-0775 has been found plying without route permit by the Secretary RTA during checking and this bus was impounded vide challan number 0094328 on dated 12-02-2016 by this office. After that the matter was placed before the RTA meeting held on 16-03-2016 vide item No. 2 & 3 for consideration. The following decision has been taken by the RTA: -</p> <p style="text-align: center;"><i>“The RTA has decided to accord the replacement permission of other bus subject to clearance of taxes due and payment of penalty prescribed in the letter No. STA 4-3/89-1047207 dated 27-05-2014 upto dated 13-07-2015 i.e. date of application for replacement of other bus on permit filed by the applicant.”</i></p>

The matter was placed before RTA meeting was held on dated 02-07-2022 for consideration. 19958 dated 21-08-2024 & letter No.-20010 dated 23-08-2024 for replacement of bus No. HP33C-0775 to HP33D-0775 and permit renewal. Hence the matter is kindly placed before RTA for consideration.

Decision of RTA:--

RTA observed that the applicant had sold his bus in the year 2014 and permit has expired in the year 2018. On the request of applicant the replacement permission has been granted in the year 2015 but applicant failed to purchase/produce bus within stipulated period. Applicant, however replaced another vehicle without permission on this route which was impounded by the RTO in the year 2016. RTA on the request of the applicant again granted replacement permission in the year 2016 with the condition of clearance of all the due taxes/penalty but again the applicant failed to purchase/produce and release the impounded bus. The applicant has now again applied for permission to replace the bus. RTA after perusal of all relevant record and detailed discussion as made above, observed that despite repeated permissions for replacement as well as release of bus granted by the RTA in the year 2015, 2016 and 2019. Applicant has utterly failed to replace/release the bus and make his route operational which is non-operational since 2015 after sale of his bus.

Hence, after detailed deliberations and keeping in view all the facts and circumstances of the case, RTA rejected the application of the applicant and further directed the Secretary, RTA Kullu to initiate the process for cancellation of his permit expired in the year 2018 under the provisions of Section 86 of the Motor Vehicles Act, 1988 and as per the decision of the State Transport Authority dated 20.05.2022, after following the due process of law.

Detail of the Case:--An application of Shri Tejender Pal S/o Shri Bali Ram resident of Village Garsala, Post Office and Tehsil Sainj, District Kullu, Himachal Pradesh has been received by this office through Secretary, STA cum Additional Commissioner Transport Himachal Pradesh vide his office letter Number C.T.9-129/Kullu/2019-10962 dated 02-06-2023 and C.T.9-129/Kullu/2019-11135 dated 13-06-2023 for renewal of route permit and replacement of bus. His bus number HP30A-0646 which plied on Neuli-Sainj-Aut-Kullu route. But this bus met with an accident on 4-7-22 while it was plying out side the permitted route by 3 kms. The route permit of above bus expired on 25-09-2022 and applicant submitted an application for renewal of route permit on 07-11-2022. He informed to this office that he is prepared to pay outstanding SRT. But the same could not be renewed as the codal formalities were not complete and technically the permit could not be renewed unless accompanied by the permission of replacement of the bus.

So the applicant applied for renewal of permit along with permission of replacement to the Director Transport Shimla on dated 20-5-23. The application of the applicant was forwarded to RTO Kullu vide above referred letter for further necessary action in the matter so the matter is presented before the RTA for favour of consideration.

Decision of RTA:--The RTA after perusal of all the relevant record, observed that the applicant applied well within the prescribed limit for renewal of the permit and the fitness certificate & route permit were valid when the ill-fated bus met with an accident and the SRT was also up to date. But the operator failed to complete codal formalities prerequisite to the renewal of permit and also did not apply

Since the applicant has now applied for the renewal of permit and replacement of vehicle, the RTA examined the case and after considering all the facts of the case observed that renewal and replacement of the vehicle can be allowed simultaneously subject to payment of pending dues, taxes and penalty. 

Item No. 14: - Consideration of case regarding plying of buses toward Keylong through Atal Tunnel in compliance of letter No. C.T.9-129/Kullu/2019-13486 dated 31-08-2023.

It is brought to your kind notice that all the traffic along with stage carriage buses (HRTC & Private) plying from Manali toward Keylong were used to ply through Rohtang pass. But as now Atal Tunnel has been opened for all types of vehicles and traffic is moved through Atal Tunnel. It is also pertinent to mention here that in compliance with the orders of the Hon'ble NGT, the administration doesn't allow to ply diesel vehicles through Rohtang and all Diesel vehicle and stage carriage buses are plying on their route through Atal Tunnel.


Apart from this, it is brought to kind notice that the electric buses are being plied by Himachal Road Transport Corporation Kullu Depot from Manali toward Rohtang for the convenience of the tourists. The Stage Carriage buses plying at Manali - Keylong route via Atal Tunnel in compliance to NGT orders is plying in violation of the route permit as allotted to them. There is an issue also arises that due to movement of traffic through Atal Tunnel time and distance also reduced which cause to time table violation. So, there is a need to modify the route permits of Stage Carriage Buses (HRTC and Private) plying of Manali - Keylong-via- Rohtang route to Manali to Keylong -via- Atal Tunnel.


Decision of RTA:- RTA examined the matter and observed that the decision on the issue has already been taken at Item No. 2 , Sr No. 1 to 4 for private buses and Item No. 18 at Sr. No. 1 to 10 for HRTC Keylong.

Items No : 17:- Consideration of following Contract Carriage Route Permits for Auto Rickshaw (Passenger) permit (beyond 4 years) are placed for renewal.

Decision of RTA:- RTA examined all the 145 cases placed before it for renewal of permit of auto-rickshaws and observed that details of the fitness of all these vehicles have not been mentioned in the agenda item. Further, RTA observed that the details of permit number and validity of permit of many vehicles have not been mentioned. In view of above, RTA deferred the agenda item and directed the Secretary, RTA to re-examine each case thoroughly with regard to fitness and payment of taxes of the all these auto-rickshaws and placed all such cases whose fitness is currently valid and all due taxes/penalties have been paid, before the Chairman, RTA by circulation for consideration and decision.

RTA further directed the Secretary, RTA to identify and verify the auto-rickshaws whose permits & fitness have been expired long back and are not physically available, and placed all such cases before the Chairman, RTA by circulation for further consideration and decision.


