Proceeding of the R.T.A. Meeting held on dated 25-04-2019.

Item No.1:- Consideration of case of Sh. Bhupesh Nandan, S/o Sh. R.N. Bhardwaj, R/o VPO. Khokhan, Teh. & Distt. Kullu, H.P. with appeal No.23/2013 & appeal No 7/2013.

Brief facts of the case are as under:-


Sr. No.	Dated	Brief history of the case
1.	11.12.2007	A route permit in favour of Sh. Bhupesh Nandan, S/o Sh. R.N. Bhardwaj, R/o VPO. Khokhan, Teh. & Distt. Kullu, H.P. has been issued for the route Bhunter-Baloo [4RT] with Bus No. HP66-1221(42+2)
2.	23.11.2009	The Bus (HP66-1221) meets to an accident.
3.	24.11.2009	The owner of permit lodged FIR.
4.	04.05.2010	The owner applied before the Secretary RTA for replacement of bus.
5.	24.06.2010	Replacement permission issued to the applicant.
6.	19.01.2010	One another route permit known as Bradha – Bhunter [1RT], Bradha – Baloo [1RT] sanctioned in favour of Sh. Bhupesh Nandan. But the grant letter not issued to the applicant.
7.	07.10.2010	The matter of grant letter placed before RTA in its meeting held on dated 07.10.2010 in which case was deferred.
8.	06.12.2012	A registered notice has been served to the owner of permit to deposit SRT amounting to Rs. 1,68,392/- and penalty 25% per annum.

9.	26.08.2013	The Owner of Bus deposited token tax of bus No. HP66-1221 vide receipt No. AB40476. For the period 01.01.2010 to 30.06.2010.
10.	07.07.2013	The owner filed an appeal before the Ld. Transport Tribunal under appeal No. 23/2013 for exemption of taxes and release of route permit known as Bhunter – Baloo [4RT].
11.	26.12.2018	The appeal No. 23/12013 was disposed of by Ld. STAT with the direction that appelland would make a representation within 10 days from the date of decision about his grievances as averred in the appeal with the RTA Kullu, and that RTA Kullu has to be decide such representation in accordance with law within a period of six weeks in the presence of parties.
12.	21.01.2019	The appelland submitted representation before the Secretary RTA Kullu.

Items of the prayer in appeal No 23; (a) Seeking exemption of taxes with respect to the permit Bhunter -Baloo(4RT).
(b) Seeking of the permit grant for Bradha – Bhunter [1RT], Bradha – Baloo [1RT] route

Items of the prayer in appeal No 7; (a) Seeking exemption of taxes with respect to the permit Bhunter-Baloo(4RT).
