

Decision: - The proceeding of last RTA meeting held on 30-05-2019 was perused and same confirmed.


Item No.2: - Issuance of new stage carriage route permits (Advertised Routes) Applications published in newspaper dated 14/02/2019 and placed before the RTA for its decision: -

New Stage Carriage route permits were identified by the Route Identification Committee constituted by the Department of Transport under the Chairmanship of Additional Deputy Commissioner Kullu, H.P. vide letter No. CT-9-130/Publication of Routes/2014-1050225 dated 12/09/2014 in compliance of order of Hon'ble High Court of H.P. in CWP No.7295/2012. The routes recommended by Committee has been advertised/published by the Department Transport in the newspaper dated 14/02/2019 for inviting applications for the routes published on above date. The applications received from the applicants for the issuance of new stage carriage on advertised routes are placed before the RTA for its consideration and taking decision in the matter. 


Decision of RTA: -







Item No.3:- Ex-post facto approval of the Cancellation of route permit of bus No. HP65-7065 and matter of replacement permission.

The Vehicle No. HP65-7065 met with an accident on 20-06-2019 in which 45 precious human lives were lost and 40 innocent people suffered serious injuries and pain. The perusal of magisterial enquiry report clearly brings about lapses on the part of bus operator Ms Mahvir Bus Service is as under:

The operator had three trips sanctioned on the same route i.e. 01:30 PM, 02:15 PM and 03:00 PM but on that ill fated day, he missed two routes at 01:30 PM to 02:30 PM resulting into overloading/overcrowding in bus No. HP65-7065 at 03:15 pm. This way the bus carried 85 passengers against the seating capacity of 44 passengers. Further, report clearly mentions mechanical failure as one of the major causes of the fatal accident. The Operator has failed to ensure safety of passengers.

Thus keeping in view the lapses on the part of owner of this bus service/route permit, leading to the fatal accident causing unbearable losses to innocent families, his route permit is cancelled by worthy Chairman RTA on dated 10/07/2019 through single file rotation.

The owner of the bus submitted an application on dated 16/08/2019 received in this office on dated 19/08/2019 for the replacement of bus with the plea that he has no other source of income so he seek the replacement permission. Hence the matter is placed before the RTA for consideration please.

Decision of R.T.A.:-

The case was called and the applicant was granted the opportunity of being heard. The plea of applicant operator was found baseless because he owns two more permits to operate the vehicles on the same route. It has also come out in the magisterial enquiry that he was irregular and not operating his buses on his other routes permits on the same route and on the ill fated day overloading led to fatal accident on 20-06-2019 where 45 innocent people lost their lives. R.T.A therefore came to the conclusion that accident occurred due to the negligence of operator. Hence RTA granted post facto approval for the decision taken by Director Transport on the Directions of the Government.

Item No. 6: - Consideration of case of Sh. Bhupesh Nandan, S/o Sh. R.N. Bhardwaj, R/o VPO. Khokhan, Teh. & Distt. Kullu, H.P. to release the route and renew permit of Bus No. HP66-1221

The applicant requested for the renewal of route permit No. 244/Reg/Stage/2007 of bus No. HP66-1221 for Bhunter – Baloo [4RT] was expired on dated 10.12.2012 which was not renewed till date. The bus was met to an accident on dated 23.11.2009 and Special Road Tax has not been paid after may 2010 due to which the owner of said vehicle default to SRT amounting to Rs.1,79,256/- and the case of recover the special road tax has been sent to ALR on dated 28/02/2013. The owner filled an appeal before the Ld. Transport Tribunal under appeal No. 23/2013 for exemption of taxes and release of route permit known as Bhunter – Baloo [4RT]. The appeal No. 23/12013 was disposed of by Ld. STAT on dated 26-12-2018 with the direction that appellant would make a representation within 10 days from the date of decision about his grievances as averred in the appeal with the RTA Kullu, and that RTA Kullu has to be decide such representation in accordance with law within a period of six weeks in the presence of parties. The appellant submitted representation before the Secretary RTA Kullu on dated 21-01-2019. The matter was placed before RTA for its consideration on dated 25-04-2019 RTA heard the applicant but decision could not be taken due to absence of RTA member the case was deferred to next RTA meeting held on dated 30-05-2019. And found that the route permit and RC of vehicle were not deposited with the competent authority but the appellant plead that his bus met with accident and not in the condition to ply on road. So the RTA give him opportunity to produce the proof of non plying of bus in the route before the secretary RTA Kullu which he failed to do so.


As the case of applicant already decided by the RTA as per Hon'ble Court decision in CWP No. 7496/2014 RTA can't review its own decision regarding issuance of stage carriage permit. Hence as per the applicant request the matter is placed before the RTA for decision please.

RTA Decision: - The case of the applicant was deliberated by the RTA in its meeting held on dated 30-05-2019 where RTA give an opportunity to produce the the documentary proof of non plying of bus in the route in the next meeting. - b) Route permit of vehicle no.HP66-1975 Permit No. 460/RTA/K/2010 for the route Bhunter – Bradha [2RT], Bhunter-Siyah [1RT] was valid upto 15/08/2015.The owner sold the said vehicle to Panjab, the NOC in respect of Bus No. HP66-1975 has been issued from this office to DTO Sangroor which was registered at DTO Jalandhar with Reg. No. PB08CB- 7079 w.e.f. 21/11/2012. The owner of bus did not apply for the replacement of bus on the said route while he deposited fees for renewal of permit amounting Rs.1550/-on dated 31/8/2015.The case was placed before RTA for consideration in its meeting held on dated 16/07/2016 in which “RTA decided to release the permit subject to payment of penalty prescribed in letter dated 27/05/2014 and if the holder of the permit fails to get the permit released on or before 31/10/2016 then it will be deemed cancelled automatically”. The applicant failed to release permit till date, and now on dated 18/06/2018 applicant submitted application for renewal of route permit again. The case of renewal of route permit was placed before the RTA in its meeting held on dated 21/06/2018 and RTA decided that the case was already decided by RTA in its meeting held on 16/07/2016 and the applicant failed to get released his route permit on or before 31/10/2016 hence permit already stands cancelled so no action requires at this stage. Now the applicant once again submitted an application for the renewal of said permit. The case is placed before RTA for consideration please.

Decision of RTA:- The case was already decided by the RTA in its meeting held on dated 16/07/2016 and 21/06/2018 hence RTA decided to reject the application.

During the meeting members were apprised that the permits of Auto-Rickshaw in the state are issued under self-employment scheme on following conditions that:


- The permit holder is a local resident of the area for which permit was granted
- The applicant is unemployed and he holds valid driving license and in the event of the grant of permit, he will drive the autorickshaw himself.
- Auto- Rickshaw will be operational within the radius of 20 KM from each place for which permit was granted.
