
The proceeding of the last meeting of RTA held on 15.10.2024 is added below for kind perusal and confirmation of the RTA please.


**RTA Decision:-**


**The RTA after going through the record placed before it, The RTA allowed ex-post facto approval of the action taken by the Secretary, RTA.**
