ITEM NO. 01 CONFIRMATION OF PROCEEDINGS OF THE SPECIAL MEETING OF REGIONAL TRANSPORT AUTHORITY, KULLU, HELD ON 27.03.2025 AT DIRECTORATE OF TRANSPORT, SHIMLA.

RTA Decision: The Secretary, RTA Kullu presented the implementation status of the decisions taken in previous Special RTA meeting held on 27.03.2025 at Directorate of Transport Shimla and after deliberations the same was confirmed.

ITEM NO. 2: APPLICATIONS RECEIVED FOR GRANT OF MODIFICATIONS/EXTENSION/CURTAILMENT & ALTERATION OF ROUTES UNDER SECTION 80(3) OF THE MOTOR VEHICLE ACT, 1988.

Under this item, the office had received 39 numbers of applications wherein, the applicants had requested for the grant of extension/ curtailment/ variation and addition of trip on one of the stretch of the route. In this regard, in a COPC No: 130/2019, the Hon'ble High Court of HP, on 12.09.2019 passed the orders that "there is irregularity/illegality in the procedure adopted by the officers of the State, therefore, they are permitted to review all such proceedings under the order of the Court and report compliance". *"It is made clear that such proceedings shall be reviewed strictly in accordance with law, so as to bring them in conformity with the provisions of the Motor Vehicles Act and Rules"*.

Accordingly, the Director Transport, HP vide his office letter number CT-9-Court Case/Review/2019-1080882 dated 19.09.2019 issued instructions that in many cases of extension of stage carriage route permit the provisions of section 80 of the CMV Act, 1988 are misinterpreted that 24 kms of extension or variation in route can be allowed many times whereas it is to be only 24 kms or less in original route permit.

Therefore, after a detailed examination of the cases under the provisions of the CMV Act 1988 and the Rules made thereunder along with the directions/ instructions referred to above, RTA decided the cases on the following aspects. The decision taken on each case is mentioned against them respectively as under:-

- Whether the route asked for is passed for a bus having particular seating capacity.
- The extension sought is not more than 24 kms (as per Hon'ble High Court's Order)
- The route asked for is having sufficient time table frequency
- The applicant is not an SRT/ Tax defaulter.





ITEM NO. 4: - APPLICATIONS RECEIVED FOR DECREASING/INCREASING OF SEATING CAPACITY IN STAGE CARRIAGE BUSES AND REPLACEMENT OF BUSES: -


The following stage carriage bus operators have applied for replacement permission of their stage carriage buses with lower seating capacity in the prescribed format issued by the Directorate of Transport H.P. These cases are to be considered in the light of directions issued by the Commissioner Transport, Himachal Pradesh, Shimla-04 vide letter No.C.T.-9-131/Specification/Directions/06-35025-34 dated 18.12.2006. Hence, cases are submitted before the RTA for consideration and decision please.


The RTA considered these applications and after examining these applications on the basis of information available on frequency of buses on various routes in the district, model/manufacturing year of stage carriage bus, no. of new route permits sanctioned, flow of vehicular movement/traffic increase on the road, bus fleet with the operators and financial implications of reduction on seating capacities, road safety issues regarding replacement of old buses with new BS-VI norms buses and to provide environmental friendly and better bus service facility to the public in the district. RTA decided these applications as per the decision given in remarks column against each case, subject to the following conditions as circulated vide letter No. STA/Meeting/24.02.2020/1-2020-1085740 dated 20.08.2020 and STA meeting dated 23-05-2025 vide item No. 3:-

1. The replacement is allowed for new or stage carriage buses upto 12 years old from the date of its first registration.
2. The replacement is allowed between Bonafide Himachalis only.
3. The condemned buses of HRTC shall not be allowed for such replacement by the private bus operators within the State.
4. Buses proposed for replacement, whether registered within the State or outside the State, must not be more than 12 years old from the date of their initial registration.


RTA further decided that no further reduction in the seating capacity of these route permit buses will be allowed within five years.

ITEM NO. 5: - CONSIDERATION OF CASE OF SH. SUDESH KUMAR S/O SH. PATHANU RAM VPO. RAKAR TEH. BAIJNATH DISTT. KULLU H.P. FOR THE ISSUANCE OF GRANT LETTER IN RESPECT OF PALAMPUR – MANALI ROUTE PERMIT ISSUED IN THE YEAR 2001 & IN REFERENCE OF DIRECTORATE OF TRANSPORT LETTER NO. C.T.9-129/DEMAND/KULLU/2024-5078 DATED 27-09-2025 REGARDING REPLY OF EXECUTION PETITION UNDER ORDER 21 RULE 2 OF THE CODE OF CIVIL PROCEDURE FOR EXECUTION OF THE ORDERS PASSED BY LD. STAT IN APPEAL NO. 3 OF 2020, DATED 17-03-2021.

With reference to the cited item, the matter is summarized below:

- (i) The applicant Sh Sudesh Kumar was allotted route permit –Palampur – Manali- 2 ST in 2001 and was issued the Grant letter.
- (ii) But he could not procure two buses required to fulfill 2 ST and operated only one bus as 1ST.
- (iii) Hence he could only be issued 1 ST Permit.
- (iv) The applicant applied for issuance of 2 ST permit for his Palampur –Manali route which was placed in the RTA meeting dated 27-09-2019 but the request was rejected owing to the fact that the validity of the grant letter had expired long ago.
- (v) The applicant approached the STAT against the orders of the RTA dated 27-09-2019 vide appeal no. 3/2020
- (vi) The Learned Tribunal accepted the appeal and directed the RTA to “consider the application of the applicant and modify the route permit for the route Manali- Palampur from 1 ST to 2ST forthwith”
- (vii) But the RTA again rejected the application after considering it in the RTA Meeting dated 02-07-2022 saying that since the applicant failed to procure the bus and the validity of the grant letter expired it was not possible to issue the permit now.
- (viii) So the applicant filed an Execution petition in the Ld. Tribunal on dated 06-03-2022 and the Ld Tribunal referred the same to the CJM Kullu on 14-05-2025 for further adjudication the Hon’ble CJM/ Civil Judge Sr. Division Kullu has started the proceedings and the next hearing is fixed for 28-11-25.


Ld. Tribunal has passed the order on 14-05-2025 that since the property of the RTO Kullu was situated under the jurisdiction of Sr Civil Judge-cum-CJM Kullu the case be transferred to the court of Ld. Sr Civil Judge-cum-CJM Kullu for execution of the orders under intimation to the Ld. Tribunal.

RTA Decision:- RTA examined the case and observed that the Hon'ble State Transport Appellate Tribunal, vide its decision in Appeal No. 3 of 2020, allowed the appeal in favour of the applicant for modification of the route permit for the Manali-Palampur route from 1 ST to 2 ST. After detailed deliberation, the RTA considered the applicant's request and approved the modification of the permit, as well as the grant letter for procurement of a bus on the said route. The RTA further directed the Secretary, RTA to take necessary action in the matter and to apprise the Hon'ble Court of the CJM/Civil Judge (Senior Division), Kullu of the RTA's decision on the next date of hearing.

ITEM NO. 6 **CONSIDERATION OF THE CASE OF SH. TEJENDER PAL S/O SHRI BALI RAM RESIDENT OF VILLAGE GARSALA POST OFFICE AND TEHSIL SAINJ DISTRICT KULLU HIMACHAL PRADESH FOR RENEWAL OF STAGE CARRIAGE ROUTE PERMIT AND REPLACEMENT OF BUS NO. HP30A-0646.**

It is submitted that the case of renewal of stage carriage route permit and replacement of bus No. HP30A-0646 has been approved by RTA Kullu in its meeting dated 15-10-2024 vide Item No. 5(A) Sr. No. 2, the detail of case is as under:-


In this regard, it is submitted that applicant has submitted an application on dated 24-03-2025 for renewal of route permit, replacement of bus and exemption of SRT for non-plying of bus due to accident on 04-07-2022 to till date. In this regard, single file has been placed on dated 24-03-2025 before the Chairman RTA, Kullu for consideration and necessary directions and requested the extension may kindly be granted to the operator till 30-06-2025 to execute formalities regarding exemption of the SRT. Chairman RTA directed that forward his case for tax exemption on checklist, after that tax exemption case has been placed before the Chairman RTA vide this office letter No. TPT-RTA(K) Tax Exemption / HP30A-0646/2025/- 17128 dated 08-05-2025, same has been exempted w.e.f. 01-05-2023 for Token Tax and 04-07-2022 for SRT to till date vide Government Notification No. TPT-C(9)-1/2025-II dated 28-07-2025 at Sr. No. 3.


RTA Decision:- RTA examined the above case in detail and observed that the matter regarding renewal of the stage carriage route permit and replacement of bus No. HP30A-0646 is in order. Accordingly, the RTA approved the replacement of the bus in favour of the operator and renewed the route permit. The RTA further decided that the operator shall replace the bus within six months from the date of issuance of the replacement permission.

ITEM NO. 7 CONSIDERATION REGARDING RECTIFICATION OF MODIFICATION DONE IN ROUTE PERMIT OF SH. RAJAT JAMWAL IN RTA MEETING DATED 15.10.24.

On the above cited item, it is submitted that in the RTA meeting dated 15.10.2024, vide item no. 2, sr no. 23, amendment was made in the stage carriage route permit Kullu-Badyoli-05 RT of Shri Rajat Jamwal, son of Shri Hira Singh, resident of Meian Behad tehsil and district Kullu, Himachal Pradesh, in which 24 kilometers was extended from Bajaura to Balu. Consequently, after checking the office documents, it was found that this route permit has also been amended in the RTA meeting dated 27.09.2019, item no. 4, sr no. 18. Originally this permit was from Kullu to Dalshani-04 RT, then in the RTA meeting dated 27.09.2019 it was changed to Kullu to Badyoli-05 RT and now in the RTA meeting dated 15.10.2024 it has been increased by another 24 kms which is in violation of Section 80(3) of the Motor Vehicles Act 1988, hence it is requested to cancel the modification made in this permit.

It is further requested that the applicant, Sh. Rajat Jamwal, has requested that the amendment to the above route permit be withdrawn and the amendment be approved for his other route permit, Kullu to Badogi-03 RT, which was placed before the RTA in the same meeting on 15.10.2024 vide Item No. 2, Sr No. 21, but the same has been rejected in the meeting proceedings. In this context, it is submitted that this route permit, Kullu to Badogi-03 RT, was newly issued at the RTA meeting on 27.09.2019, and no amendments have been made to it yet.

In this context, it is further submitted that the above case has been placed before the Chairman RTA, Kullu on a single file on dated 25-06-2025 for review the case in the light of directions issued by Hon'ble High Court of HP in CoPC No. 40/2020, 237/2018, 130/2019 & 12/2020 as the same has been approved in violation of Sec. 80(3) of CMV Act, 1988 because the applicant inadvertently furnished wrong information.

Decision of RTA on a single file on dated 07-07-2025:-

In view of the inadvertent approval granted due to error in data of distance, the approval for extension granted is required to withdrawn. However, before the same is carried, Secretary RTA, is directed to issue notice to this effect to the applicant requesting him to submit his reply to the notice within 7 days and thereafter re-submit the case for consideration of Competent Authority.



Accordingly, the RTA directed the Member Secretary to issue a notice of at least one month to the concerned operator as per the above provision. After receiving the reply, the same shall be examined under the Motor Vehicles Act and the matter placed before the RTA in its next meeting for consideration and decision.



RTA Decision:-

The RTA examined both cases in detail and observed that the earlier decisions of the RTAs taken in the years 2019 and 2022 cannot be implemented in the present scenario, as the road conditions, traffic volume, and operational circumstances have significantly changed. Several sections of the concerned routes have undergone alterations in road alignment, widened traffic flow, increased congestion, and revised safety considerations, making the earlier decisions unsuitable for current operating conditions. Hence, RTA directed that the applicants shall submit fresh applications, if they so desire, for consideration in the next RTA meeting. Accordingly, both applications were rejected.







RTA meeting Kullu dated 02-07-2022 vide item No. 4 Sr. No. 13, RTA allowed the case for the transfer of stage carriage permit from Sh. Jagdish Thakur S/o Sh. Dole Ram VPO Bajaura Tehsil Bhunter Distt Kullu HP to M/s Aananu Tour & Travels.


On the above context, we have seek the guidelines from directorate of transport vide this office letter No. TPT-RTA(K) RTA/2024/-13383-84 dated 16-11-2024 and same was replied vide your office letter No. C.T.9-129/Demand/Kullu/2024-21761 dated 10-12-2024. Further this office asked/comment on the matter from the applicant vide this office letter No. TPT-RTA(K) RTA/2024-13708 dated 10-12-2024 that since she has applied for the execution of RTA decision of dated 02-07-2022 after a lapse of 2 years, It has further come to light that, they has added the bus bearing registration No. HP34E-7513 on to an old permit while the old bus still stands on the VAHAN portal, hence she could not have done so without scrapping or transferring the old bus. Similarly the address and name of the operator in the new RC doesn't match as per the RTA decision.

On the aforesaid letter of this office she explained her position that she has updated her address on Aadhar Card to Mandi from Bhunter and for old bus No. HP34A-1829 was involved in case FIR No. 07/17 dated 07-03-2017 at CID Bharari hence the bus cannot be transferred or scrapped until the final outcome of Hon'ble court. All the facts were placed before the then Director Transport and the then RTO Kullu at the time of RTA meeting. After that the case was placed before the RTA on a single file rotation on dated 01-01-2025 for necessary guidelines that whether we can issue the transferred route permit in compliance of the above referred decision of RTA on 02-07-2022 after a lapse of two years, so that rest of cases of RTA meeting dated 02-07-2022 for modification and other cases may be dealt with same analogy.

RTA decision in a single file rotation on dated 30-01-2025:-

RTA has approved in its meeting held on 02-07-2022 for transfer of permit along with vehicle No. HP34A-1829 from the name of Sh. Jagdish Thakur to M/S Aananu tour travels Prop. Smt. Taruna Sharma. However, instead of getting the transfer of original route permit inserted, she has got inserted new vchicle on the route permit which was not permissible before actual transfer of permit. However, before the final decision is taken in the matter, Secretary RTA Kullu is directed to re-examine the entire case by associating the original owner of route permit and submit detailed report along with recommendation to Chairman RTA by circulation for appropriate decision/order.

In this regard, it is further submitted that the case was re-examined and found that token tax in RLA Kullu and SRT in this office is pending at present. In this context, show cause notice has been served to Smt. Taruna Sharma vide this office letter No. TPT RTA(Kullu) RTA/2025-17229 dated 26-05-2025 and again letter sent to Smt. Taruna Sharma regarding clarification of above said letter vide this office letter No. TPT RTA(Kullu) RTA/2025-17383-385 dated 04-07-2025 and copy of which is also forwarded to Chairman RTA, Kullu

RTA decision in a single file rotation on dated 28-03-2025:-

Secretary, RTA has neither examined the case thoroughly nor submitted complete facts of the case and recommendation. Hence Secretary, RTA is directed to examine the case and submit the details facts and recommendation by circulation.

After this file was again placed before the RTA by circulation on dated 01-05-2025 with the submission that the matter was examined as directed and it was found that the amended proposal of the operator falls within the permissible limit of modification/extension of route stipulated at section 80(3) of the MV Act, as now the operator wants to extend the route by 4.90 kms (distance certificate of HPPWD given) at one of the terminus viz. Mashnathach to kalang as his existing route is Kullu –Naguijhor-Mashnathach (5RT). Further submitted that route permit Kullu-Naguijhor-Masanthach-05RT was issued to the applicant Sh. 
Sh. Bhupesh Nandan Sharma S/o Sh. R.N Bhardwaj Village Shurad Post Office Khokhan Tehsil Bhuntar District Kullu H.P. has submitted an application or complaint regarding reconsideration of wrong modifications which was accorded/granted in previous RTA meetings Kullu. He has requested to check or reconsider the grant of extension/ curtailment/ variation and addition of trip on one of the stretch of the route.


In this regard, it is apprised that, in a COPC No: 130/2019, the Hon'ble High Court of HP, on 12.09.2019 passed the orders that "there is irregularity/illegality in the procedure adopted by the officers of the State, therefore, they are permitted to review all such proceedings under the order of the Court and report compliance". "It is made clear that such proceedings shall be reviewed strictly in accordance with law, so as to bring them in conformity with the provisions of the Motor Vehicles Act and Rules".

Accordingly, the Director Transport, H.P. vide his office letter number CT: 9-Court Case/Review/2019-1080882 dated 19.09.2019 issued instructions that in many cases of extension of stage carriage route permit the provisions of section 80 of the CMV Act, 1988 are misinterpreted that 24kms of extension or variation in route can be allowed many times whereas it is to be only 24 kms or less in original route permit.





RTA Decision:- RTA examined the above cases in detail and observed that the these cases should be dealt by the RTA as per the provision contained in sub section 2 clause (xxii) of section 72 of the MVAct, 1988 read with Section 86 of the Act ibid. Accordingly, the RTA directed the Member Secretary to issue a notice of at least one month to the concerned operator as per the above provision. After receiving the reply, the same shall be examined under the Motor Vehicles Act and the matter placed before the RTA in its next meeting for consideration and decision.

ITEM NO 16 CONSIDERATION OF CASE IN THE LIGHT OF INSTRUCTION DATED 20/05/2022.

Sh. Gulshan Kumar has submitted an application for re-consider his case as placed before RTA in its meeting dated 15-10-2024, the detail of which is given below:-

Sh. Gulshan Kumar sold his bus HP33C-0775 on dated 02/12/2014 which was entered in the route Permit No. 264/RTA/K/2008 which was valid till 12/02/2018. The applicant requested for the replacement of the vehicle on dated 05-02-2015 and the replacement permission had been issued to the applicant by this office letter No. RTA (K) Stage Carriage/HP33C-0775/3135 dated 19-02-2015 with the condition that the owner of the vehicle shall be produce new bus within three months on or before 04-05-2015. But the applicant failed to produce new bus during the stipulated period. The applicant had produced the documents of another bus bearing registration No. HP33D-0775 10th July 2015 after the lapse of about 8 months of selling the previous vehicle; this matter was to be placed before the RTA meeting for consideration for approval. But during the period the bus number HP33D-0775 has been found plying without route permit by the Secretary

RTA during checking and this bus was impounded vide challan number 0094328 on dated 12-02-2016 by this office. After that the matter was placed before the RTA meeting held on 16-03-2016 vide item No. 2 & 3 for consideration. The following decision has been taken by the RTA: -

"The RTA has decided to accord the replacement permission of other bus subject to clearance of taxes due and payment of penalty prescribed in the letter No. STA 4-3/89-1047207 dated 27-05-2014 upto dated 13-07-2015 i.e. date of application for replacement of other bus on permit filed by the applicant."



But the applicant failed to get the bus released till date and moved an application dated 23-11-2019 for renewal of route permit along with replacement permission by the applicant in this office. The matter was placed before RTA meeting was held on dated 02-07-2022 for consideration. The decision has been taken by the RTA, "The applicant failed to get release of the bus route as per RTA decision held on dated 28-03-2016. Hence the RTA decided that the route permit cannot be released accordingly. Moreover letter No. STA/4-3/89/2014-2665 dated 20-05-2022 is also clear that case does not fall under the purview."

The applicant has again submitted an application in this office on 22-06-2023 and has informed that he is ready to pay penalty of Rs.10000 per month and outstanding special road tax from 3-12-14 till the date of application for replacement of permit. But this route was non-operational since 12-02-2016 i.e. more than 4 years. He again requested through Hon'ble Deputy CM of HP w.r.t. their UO letter NO. S.O./DCM/2024-6979 dated 20-08-2024 and directorate of transport vide letter No. C.T.9-129/Kullu/2023-19958 dated 21-08-2024 & letter No.-20010 dated 23-08-2024 for replacement of bus No. HP33C-0775 to HP33D-0775 and permit renewal. Now the applicant has again submitted an application in this office on 22-10-2025 and has informed that he is ready to pay the penalty.

Decision of RTA in 15-10-2024:-

RTA observed that the applicant had sold his bus in the year 2014 and permit has expired in the year 2018. On the request of applicant the replacement permission has been granted in the year 2015 but applicant failed to purchase/produce bus within stipulated period. Applicant however replaced another vehicle without permission on this route which was impounded by the RTO in the year 2016. RTA on the request of the applicant again granted replacement permission in the year 2016 with the condition of clearance of all the due taxes/penalty but again the applicant failed to purchase/produce and release the impounded bus. The applicant has now again applied for permission to replace the

bus. RTA after perusal of all relevant record and detailed discussion as made above observed that despite repeated permissions for replacement as well as release of bus granted by the RTA in the year 2015, 2016 and 2019. Applicant has utterly failed to replace/release the bus and make his route operational which is non-operational since 2015 after sale of his bus.


Hence, after detailed deliberations and keeping in view all the facts and circumstances of the case, RTA rejected the application of the applicant and further directed the Secretary, RTA Kullu to initiate the process for cancellation of his permit expired in the year 2018 under the provisions of Section 86 of the Motor Vehicles Act, 1988 and as per the decision of the State Transport Authority dated 20.05.2022, after following the due process of law.

RTA Decision:- RTA examined the case in detail and observed that the applicant's request for replacement of the bus and renewal of the stage carriage permit had already been rejected in the previous RTA meeting after due consideration. Since no new facts, documents, or grounds have been presented to justify a review of the earlier decision, the RTA found no merit in revisiting the matter. Accordingly, the RTA again rejected the application.

ITEM NO. : 17. CANCELLATION OF GRANT LETTERS ISSUED TO PURCHASE BUSES AGAINST NEWLY PUBLISHED STAGE CARRIAGE ROUTE PERMITS BY THE RTA IN ITS MEETING HELD ON 15-10-2024.

It is submitted that total 08 new stage carriage routes were granted in RTA meeting dated 15-10-2024 & 01 new stage carriage route was granted in special RTA meeting dated 27-03-2025, total 09 new stage carriage routes were granted. Out of which 04 applicants purchased buses against new routes and 01 applicant submitted application again on dated 21-10-25 and requested further for next 2 months extension of validity of grant letter as he is submitted that due to bad weather condition and floods in Punjab area total body building process was stuck off and body making process on the chassis is going on in which he wants 2 more months for complete the whole process and his case is placed in Item No. 9 Sr. No. 4 for ex-post facto approval and extension of validity of grant letter. And 04 applicants grant letters validity has expired and they are not interested to take permit. Therefore, in compliance to instructions issued vide Item No. 7 of proceedings of the departmental review meeting held on 14-08-2025 through hybrid mode, 04 cases placed below for cancellation.
