**Advertisement for the post of Member (Law), HP Electricity Regulatory
Commission (HPERC)**

The Department of MPP & Power, Government of Himachal Pradesh invites applications from interested and eligible Indian nationals for one post of Member (Law) in Himachal Pradesh Electricity Regulatory Commission (HPERC) as per the provisions contained in the Electricity Act, 2003, the rules framed thereunder, and also as per the judgement dated 12.04.2018 passed by the Supreme Court of India in State of Gujarat Vs. Utility User's Welfare Association and Ors. (AIR 2018 (SC) 4215).

As per the aforesaid judgment, the person should be holding a judicial office or should be a person possessing professional qualifications with substantial experience in the practice of Law and having the requisite qualifications for appointment as a Judge of a High Court or as a District Judge.

The qualifications for appointment as Member (Law) of the State Commission and the term of office and conditions of service of such Member are provided in section 84 and 89 of the Electricity Act, 2003, respectively. The salary, allowances & other conditions of service of the Member have been provided in the Himachal Pradesh Electricity Regulatory Commission (Salary, Allowances and other Conditions of Service of Chairperson and Members) Rules, 2006 notified on 30.11.2006, and the amendments thereto issued on 6th April, 2017, and 07.01.2025.

The Member (Law) shall hold office for a term of five years from the date on which he enters upon his office, provided that no Member (Law) shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act.

Those candidates who are interested and eligible to apply for this post may send the following information:-

- (B) Details of any office, employment or consultancy agreement or arrangement which he/ she is his/ her own name or in any firm, association or persons or body corporate, or in the names of any relative, carrying on any of the following business namely:-
- i) Generation, transmission, distribution or supply of electricity.
 - ii) Manufacture, sale or supply of any fuel for the generation of electricity
 - iii) Manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant, equipment, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity; and
 - iv) Any entity providing professional services or any of the business referred to in sub-clause (i), (ii) and (iii) above.
- (C) A letter expressing willingness to resign from his/ her post and join as Member (Law) in HPERC, if selected.
- (D) An affidavit to the effect that no criminal case is pending in any court and no disciplinary proceeding are in progress against the applicant. Further, the applicant shall also specify the details of any conviction, if any, in a criminal matter and/or imposition of penalty in departmental proceedings.
