In continuation of the Government letter No. EDN-C-A(3)-2/2018, dated 02.09.2019 and in pursuance of the provision contained in para 2.6 and para 3.10 of the guidelines of "The School Complex System" which envisages:-

Para 2.6: The Principal of the Government Senior Secondary School shall be the Administrative Head of the Complex for the purpose of day-to-day administration and implementation of all the policies, programs, schemes and companies in the Education Department. All teachers, including the Head of the subordinate schools (i.e. Headmasters, In-charge of Middle schools: CHTs) located within the complex, shall work under the overall administrative control of the Principal of the GSSS.

Para 3.10: To ensure proper implementation of all provisions of the Right to Education act and other schemes and programs being implemented in the schools of the State such as PM-Poshan, free-textbooks distribution, school uniform subsidy and scholarship schemes etc.

Accordingly, the answer sheets of all GPS, GMS, and GHS schools within a Complex shall be submitted to their respective Complex School and checked/evaluated under the supervision and control of the Principal of that Complex School.

Further, the Principal of the Complex School shall submit the consolidated report of detained students, specifically for classes 5th and 8th, on the prescribed proforma attached herewith as "Annexure A" to the concerned Deputy Director for onward submission to this Directorate within the stipulated timeframe. All concerned are directed to ensure strict compliance.
