Memo,

On the subject cited above, it has been observed by the undersigned that a large number of references are being received from all the DDSEs seeking clarifications in court case matters, specifically drawing analogies with the cases decided on the analogy of CWP No. 414/2014- titled as Kuldeep Chand Vs State & others alongwith LPA No. 54/2013 titled as State of HP Vs Om Prakash, CWPOA No. 3435/2020- titled as Satish Kumar & others Vs State & CWP No. 2004/2017- titled as Taj Mohmmad Vs State of HP and all other connected matters with these cases.

In this context, it is intimated that after the enactment of Himachal Pradesh Recruitment and Conditions of Service of Government Employees Act, 2024, notified by the Government of Himachal Pradesh on 20.02.2025, the office orders issued by this Directorate from time to time on the analogy of the cases mentioned in the above paragraph were withdrawn with immediate effect vide this Directorate office orders No. EDN-H(2)B(2)2004/2017-CC dated 25.02.2025, No.EDN-H(2)B(2)3435/2020-CC dated 28.03.2025 & No. EDN-H(2)B(2)54/2013-CC dated 28.03.2025.

Therefore, it is hereby directed that all such matters may strictly be dealt in accordance with the instructions already issued vide this

Directorate office orders dated 25.02.2025 and 28.03.2025 and as per Himachal Pradesh Recruitment and Conditions of Service of Government Employees Act, 2024, notified by the Government of Himachal Pradesh on 20.02.2025. No further clarifications shall be issued in this context separately.

Further, in those cases where the process of the orders dated 28.03.2025 has been stayed by the Hon'ble High Court of HP, in that case no further advancement will be made till the final outcome of the proceedings of the Hon'ble High Court of HP. You are further directed that no payment of installments of the arrears be made in favour of the petitioners of CWPs/CWPOAs which were decided by the Hon'ble High Court of HP on the analogy of CWPs ibid and further withdrawn by the Directorate vide office orders dated 25.02.2025 & 28.03.2025.
