In continuation to this office of even no. of dated 08.11.2024, 19.11.2024 and 07.12.2024 vide which you were directed to provide the proforma for promotion in reservation of persons with Benchmark Disabilities (PwBDs) in the services of the State Government, for inclusion of names in the TGT promotion panel amongst TET pass in-service JBTs for the promotion of TGT (Med./NM/Arts) and in-service C&Vs for the promotion of TGT(Arts/NM/Med.) as per Govt. letter No:-4/1/2021(47)-SOM-Wel-RPwD-I-16690-750 dated 1st Oct. 2024 to this Directorate of Elementary Education on or before 27.12.2024.

Subject: Medical Examination of Persons with Disabilities before joining the services under the State Government-instructions thereof.

Madam/Sir,

I am directed to say that a meeting with the representatives of Blind Persons Association, Himachal Pradesh and National Federation of Blind, Himachal Pradesh was held on 21.12.2021 under the Chairmanship of Chief Secretary to the Government of Himachal Pradesh to discuss their various demands. It has been pointed out that some candidates are securing employment under the State Government against the vacancies reserved for Persons with Disabilities on the basis of false/forged certificates. Therefore, it has been decided to conduct fresh medical examination of persons with disabilities before joining the job from competent authority so that unscrupulous persons should not secure employment against posts reserved for persons with disabilities on the basis of false medical certificates (PwD Certificate). You are, therefore, requested that before giving appointment/joining to an incumbent against the post reserved for persons with disabilities, the fresh medical examination may be got conducted from the competent authority so that veracity of medical certificate (PwD certificate) submitted by the candidate could be ensured.
