Whereas, Mamta Singh, TGT (NM) preferred CWP No. 9343/2025 titled as Mamta Singh, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GHS Panjoh, Didtt. Chamba to GMS Bhalla, U/C GSSS Kiri, Distt. Chamba, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 05-06-2025 when the Hon'ble High Court has passed the following orders:-

7. "Consequently, in view of the above, though having taken note of the fact that petitioner has already completed normal tenure at present place of posting and she wants to get herself transferred from the present school, this Court sees no reason to interfere with impugned transfer order, but deems it fit to dispose of the present petition reserving liberty to the petitioner to file representation within - 4 - two days to the competent authority, praying therein for her transfer from present place of posting to one of the school in Dharamshala, District Kangra, Himachal Pradesh or in the vicinity, enabling her to take care of her ailing in-laws. Ordered accordingly. The representation so filed shall be decided by the competent authority within ten days. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy formulated by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer on the ground of adverse family circumstances. Till the time representation is decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was submitted her representation in this office on 10-06-2025, vide which She has requested that She may be adjusted at nearby his native place in district Kangra / Distt. Una, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms.

From perusal of record, it has been found that the petitioner has been working at GHS Panjal, Distt. Chamba, H.P and under transfer to GMS Bhalla, U/C GSSS Kiri, Distt. Chamba, H.P. One Sh. Navneet, TGT(NM) is working in GMSSS(Boys) Pragpur, Distt. Kangra, H.P. since 06-08-2023. The petitioner has given willingness for her transfer to the aforesaid school against longer stay/ longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and She is hereby adjusted at GMSSS(Boys) pragpur, Distt. Kangra, H.P. vice Sh. Navneet, TGT(NM) against longer stay by clubbing his previous stay within radius of 30 Kms. and Sh. Navneet TGT(NM) is hereby transfer to GMS Bhalla, U/C GSSS Kiri, Distt. Chamba, H.P with TTA/JT. The representation of the petitioner is disposed of accordingly.
