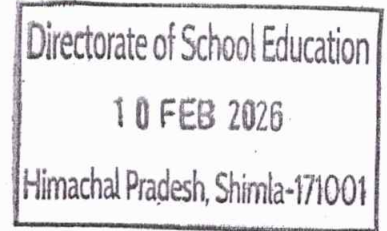

**ORDER**

Whereas, the petitioner namely Sh.Sanjay Kumar Sharma Lect.(History) is working at GSSS Haripur Khol (Smr) w.e.f 12.08.2024 and having short stay. He has filed CWP No. 793/2026 titled as Sanjay Kumar Sharma vs State of HP. This petition was listed on 08.01.2026 when the same has been finally disposed with the directions to respondents as under:-


“Though this Court finds no reason to differ with the aforesaid submission of Mr. Ravi Chauhan, learned Deputy Advocate General, but once Transfer Policy itself provides for minimum tenure of three years at one station, coupled with the fact that mother of the petitioner is not well, this Court sees no impediment in issuing direction to the respondents to consider and decide the representation of the petitioner (Annexure P-4) expeditiously, preferably within four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy formulated by the Government of Himachal Pradesh. Pending applications, if any, stand disposed of.”

And whereas, as per direction passed by Hon'ble High Court as above, the applicant was called to appear in this office for personal hearing on 09.02.2026 and he was present on this date. During the course of hearing petitioner has requested that he is unable to continue his services at present place of posting due to adverse family circumstances and further requested that he may kindly be adjusted at GSSS Shivpur (Smr) against vacancy due to retirement of present incumbent on 31.03.2026.

And whereas, while examined his representation it is found that petitioner is presently working at GSSS Haripur Khol (Smr) and having short stay and posted in soft area and GSSS Shivpur (Smr) has already been allotted in CWP NO 16074/2025.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner is being rejected and he will continue his services at GSSS Haripur Khol (Smr). Hence representation stands disposed of.
