**Subject:** Compliance of Hon'ble High Court Orders in CWP No. 9556/2023 titled as Hem Lata & Ors. Vs. State of H.P & Ors. and CWP No. 9558/2023 titled as Birender Singh Guleria & Ors. Vs. State of H.P & Ors. – Regarding Personal Hearing. on 07.08.25

Sir/Ma'am,

This is with reference to the judgment dated **24.04.2025** passed by the Hon'ble High Court of Himachal Pradesh in **CWP No. 9556/2023** titled as **Hem Lata & Ors. Vs. State of H.P & Ors.** and **CWP No. 9558/2023** titled as **Birender Singh Guleria & Ors. Vs. State of H.P & Ors.** The operative portion of the said judgment reads as under:

*“6. Consequently, in view of the aforesaid fair stand adopted by learned Additional Advocate General, this Court deems it fit to dispose of the present petitions, reserving liberty to the petitioners to file representations to the competent authority within a period of ten days, praying therein for consideration of their cases in light of judgments passed by Coordinate Bench of this Court in Pushpa Devi, Umesh Jaswal and Nitin Kumar (supra) which in turn, shall be decided by the competent authority within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioners and pass speaking order. Pending applications, if any, stand disposed of.”*

Accordingly, in compliance with the above directions of the Hon'ble High Court, you are hereby directed to appear for **personal hearing** in the office of the undersigned on **07.08.2025 at 11:00 AM**, along with all relevant supporting documents pertaining to your case, failing which ex-parte decision will be taken in the matter.
