Sir.

The department has been receiving requests for authorising re-employed / re-engaged officers to function as DDO. Further, such re-engaged / re-employed officers are to be paid remuneration from SOE-65 as notified by the FD vide notification no. Fin (C)-A (3)-5/2004 Dated 24.07.2024. Such officers cease to exist as DDOs in IFMIS on their retirement. Therefore, following procedure may be adopted regarding grant of DDO powers in offices where the officers were earlier exercising DDO powers as regular employees, but now are re-employed/re-engaged:-

"The HODs may assign DDO powers to the senior most regular officer/official in that office. However, the administrative and financial control shall remain with the officer, who has retired and re-employed but ceased to function as DDO, as per the office procedure prevalent".
