Whereas, Amit Kumar, TGT (NM) preferred CWP No. 8917/2025 titled as Amit Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Baghar Chowki, U/C GSSS Dhabas, Distt. Shimla, H.P to nearby his native place in Distt. Bilaspur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28-05-2025 when the Hon'ble High Court has passed the following orders:-

"Having perused impugned order in its entirety, this Court is compelled to observe that authority concerned has failed to consider the request of the petitioner in light of submission made in the representation, rather in most mechanical manner without verifying the facts, has proceeded to reject the representation. Mere fact that at present 32 students are studying in GMS Bhagar Chowki u/c Government Senior Secondary School, Dhabas, cannot be a valid ground to reject the representation of the petitioner, especially when he has indicated that in schools located under Education Blocks Ghumarwin and Bilaspur, there are number of teachers, who can be posted in place of the petitioner being longer stayee. Learned Additional Advocate General to have instructions or file short reply within a period of one week. List on 05-06-2025"

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office on 30-05-2025, vide which he has requested that he may be adjusted at nearby her native place in district Bilaspur, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms.

From perusal of record, it has been found that the petitioner has been working at GMS Baghar Chowki, U/C GSSS Dhabas, Distt. Shimla, H.P since November, 2021 and has completed his normal tenure of three years at present place of posting. One Sh. Praveen Kumar, TGT(NM) is working in GHS Ghiyal, U/C GSSS Namhol, Distt. Bilaspur, H.P. since 25-09-2023. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. . Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby Transfer from GMS Baghar Chowki, U/C GSSS Dhabas, Distt. Shimla, H.P to GHS Ghiyal, U/C GSSS Namhol, Distt. Bilaspur, H.P vice Sh. Praveen Kumar, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Praveen Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
