Whereas, Sh. Hari Lal, DEP/Lect. Phy. Education preferred CWP No. 13717/2025 titled as Hari Lal Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Sechunala, Distt. Chamba to GSSS Nandrool, Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 26-08-2025 when the Hon'ble High Court has passed the following orders:-

7 "Consequently, in view of the above, this Court finds merit in the present petition and accordingly the same is allowed. Impugned order dated 07.08.2025 (Annexure P-4) is quashed and set aside with the direction to respondents to consider and decide the representation of the petitioner afresh, taking note of observations made hereinabove. Needful in terms of instant judgment shall be done expeditiously, preferably, within a period of ten days. Pending application(s), if any, also stands disposed of."

In compliance to the diections of Hon'ble High Court, the petitioner has submitted his representation in this office and he has requested that he may kindly be transferred/adjusted at 1. GSSS Tangret, 2. GSSS Sissu, 3. GSSS Jahalma, Distt. Lahul & Spiti and 4. GSSS Sach(Pangi) 5. GSSS Karyuni(Pangi), Distt. Chamba, against vacancy or longer stay.

On the perusal of the record, it is found that the petitioner is working at GSSS Sechunala, Distt. Chamba and under transfer to GSSS Nandrool, Distt. Kangra, H.P. At present the post of DPE/ Lect. Phy Education is lying vacant at GSSS Tingret, Distt. Lahaul & Spiti, H.P and (8) students are studying class +1 and +2 in this school. The petitioner has given willingness for his transfer/ adjustment to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby adjusted at GSSS Tingret, Distt. Lahaul & Spiti, H.P against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
