ORDER.

In the matter : CWP No. 19777/2025 titled as Kumari Neerja, TGT(Med) VS State of H.P. & others.

The Petitioner Smt. Kumari Neerja, TGT(Med)) filed CWP No. 19777/2025 titled as, Smt. Kumari Neerja, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS, Mahog Distt. (Shimla) to District Hamirpur The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 15.12.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Having carefully perused averments contained in the petition, which is duly supported by an affidavit this court finds that petitioner has already worked for more than six years at present place of posting, but once transfer policy formulated by State of Himachal Pradesh, itself prescribes for completion of minimum tenure of three years at one place and besides this, employee can also seek transfer on the ground of adverse family circumstances, this Court sees no impediment in as much as issuing direction to the respondents to consider and decide representations of the petitioner, expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order taking note of transfer policy as well as observation made herein above. Pending applications, if any, also stand disposed of."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 16.02.2025. The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested to adjust her at District Hamirpur.

From perusal of the record, it is observed that Smt. Kumari Neerja, TGT (Medical) has been serving at GSSS, Mahog Distt. (Sml.) since 30.11.2019. She has completed the normal tenure at her current place of posting which falls in the soft area.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
