**ORDER**

In the matter of:- CWP No. 13875/2025-titled as Vikash Jaswal, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his transfer from GSSS Rajgarh, Distt. Sirmour (HP) to one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 28-08-2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

**“.....Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders.”**

In compliance with the orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on dated 03.09.2025 and appeared before the undersigned on the scheduled date. On this day, the petitioner (Sh. Vikash Jaswal, TGT (Arts) has submitted/represented that he has completed his normal tenure at the present place of posting. He has further stated that he is the only son of his parents, his father has passed away, and his mother, being a senior citizen suffering from multiple age-related ailments, has no other family member to look after his mother so that requested for his transfer either to GSSS Kuthehra, GHS Jiwani, GMS Dimmi, or GHS Patnaun, District Hamirpur.

From the perusal of record, it is found that Sh. Vikash Jaswal, TGT (Arts), was appointed at GSSS Rajgarh, District Sirmour on 31.12.2021. His services were regularized vide this Directorate order dated 12.07.2024, and he subsequently joined his duties at GSSS Rajgarh, District Sirmour on 15.07.2024 further the institution i.e. GSSS Rajgarh, Distt. Sirmour is classified as a soft area within District Sirmour wherein 308 students are enrolled. However, as per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentioned in Para 12.1 “Transfer to a particular place of choice cannot be claimed as a matter of right.”

Now, therefore, after due consideration of the facts and circumstances narrated above, the representation submitted by the petitioner has been examined. However, the same is hereby rejected on the grounds that the petitioner is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GSSS Rajgarh, District Sirmour. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. Hence, in view of the aforesaid facts and circumstances, the representation of the petitioner is rejected and stands disposed of. All the concerned are intimated accordingly.
