## OFFICE ORDER

In the matter of:

CWP.No.9861/2025- Sh. Lachhmn Singh, Shastri Vs. State of H.P. and others.

Whereas, Sh. Lachhman Singh, Shastri, preferred CWP No. 9861/2025 titled as Lachhman Singh, Shastri Vs. State of Himachal Pradesh. Before the Hon'ble High Court of H.P. regarding his transfer from GMS Makkan, U/C GSSS Jhajjakothi, Distt. Chamba to GMS Andwas, U/C GSSS Lahara, Distt. Chamba. The above writ petition was listed before the Hon'ble High Court on 17.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following- directions/Order:-

4"Having taken note of the fact that petitioner has already completed normal tenure at present place of posting, there appears to be no reason to interfere with the impugned transfer order and as such, same is upheld. However, having taken note of fact that petitioner has already served in a hard area and vide impugned transfer order, he has been again transferred to hard area, this Court deems it fit to dispose of the present petition reserving liberty to the petitioner file representation to the competent authority within two days, praying therein for his transfer to one of the stations of his choice in terms of Transfer Policy, which shall be decided by the competent authority within ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly enables an employee, who has already served in a hard area, to seek transfer to one of the stations of his choice. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be relieved, if not already relieved from present place of posting."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 18-07-2025. The petitioner appeared before the undersigned on schedule date and time and heard in person. The petitioner has requested that he may kindly be adjustet at nearby his native place in Distt. Sirmour, H.P against vacancy / longer stay.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Makkan, U/C GSSS Jhajjakothi, Distt. Chamba, H.P ( Hard Area) and under transfer to GMS Andwas, U/C GSSS Lahara, Distt. Chamba, H.P. At present the post of Shastri is lying vacant at GMS Jangla, U/C GSSS Parchod, Distt. Chamba, H.P. Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GMS Jangla, U/C GSSS Parchod, Distt. Chamba, H.P, against vacant post without TTA/JT.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly. The Dy. Director of Elementary Education, Chamba, H.P is directed to take further action in this connection under intimation to this Directorate.
