ORDER.

In the matter : CWP No. 1964/2026 titled as Rajeev Singh, TGT(Med) VS State of H.P. others.

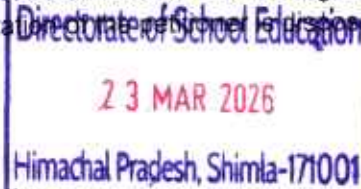
The Petitioner Sh. Rajeev Singh, TGT(Med) filed CWP No. 1964/2026 titled as, Sh. Rajeev Singh, TGT(Med) Vs. State of H.P. before the Hon'ble High Court of H.P. and seeking his transfer from GSSS, Pabiana Distt. (Sirmour) to District Kangra. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 23.12.2025 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"In light of the prayer made in the petition as well as the submission made by the learned Counsel. This petition for his transfer from the present station of his posting be considered by the Authority concerned within a period of four weeks from today and the petitioner be transferred from his present place of posting. The stations which have been mentioned in the representation by the petitioner be taken into consideration, the said stations are lying vacant. While ordering the transfer, the element of academic session can be taken into consideration by the Authority concerned. Pending miscellaneous application(S), if any also stand disposed of accordingly."

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 16.03.2026. The petitioner attended the personal hearing scheduled date and time and has submitted representation to adjust him at district Kangra.

From the perusal of the record, it reveals that Sh. Rajeev Singh, TGT (Med.) is working in GSSS, Pabiana District Sirmour which falls in soft area.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
