ORDER

In the matter of: CWP No. 1809/2026 titled as Daljit Singh, TGT (NM) Vs. State of H.P. & others.


Whereas, Sh. Daljit Singh, TGT (NM) presently working in GMS Langoie u/c GSSS Kihar, Distt. Chamba has filed CWP No. 1809/2026 titled as Daljit Singh, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that he may transferred from GMS Langoie u/c GSSS Kihar, Distt. Chamba to one of the stations of his choice in Distt. Kangra/Chamba. The case of the petitioner was listed before the Hon'ble High Court on 13.02.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"Accordingly, this petition is disposed of with a direction to the respondents/authority to decide the representation of the petitioner dated 10.11.2025 (Annexure P-2) sympathetically within a period of two weeks' from today by passing a speaking order and after giving an opportunity of being heard to the petitioner and the same shall be communicated to the petitioner. 4. It is made clear that this Court has not expressed anything on the merits of the case, and the authority shall take a decision strictly in consonance with the provisions of law. 5. Petition stands disposed of, so also the pending application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 05.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Langoie u/c GSSS Kihar, Distt. Chamba to GMS Mahar u/c GSSS Badanj, Distt. Kangra or GMS Kail u/c GSSS Mail Distt. Chamba.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Langoie u/c GSSS Kihar, Distt. Chamba since 12.06.2025. The said teacher has not completed his normal tenure of three years at present place of posting as per transfer policy, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
