In the matter of: CWP No. 16344/2024 -titled as Anil Kumar, Vs. State of H.P. & others.

Whereas, Sh. Anil Kumar, TGT (NM) preferred CWP No. 16344/2024 titled as Anil Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P. to nearby station at his native place in Distt. Hamirpur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 30-12-2024, when the Hon'ble High Court has passed the following orders:-

7. "In view of the above, this writ petition is disposed of, permitting the petitioner to prefer a fresh representation within one week from today. In case such representation is preferred, the competent authority shall consider and decide the same in accordance with law within a further period of two weeks. The order so passed shall also be communicated to the petitioner.

Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 22-02-2025. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting at GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P and he may be transferred to nearby native place in Distt. Hamirpur /Bilaspur, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P since, 22-02-2017 and has completed his normal tenure of three years at present place of posting. One Sh. Manoj Kumar, TGT(NM) is working in GHS Khuthrin, Distt. Hamirpur, H.P. since 08-01-2024. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA/JT from GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P to GHS Khuthrin, Distt. Hamirpur, H.P. vice Sh. Manoj Kumar, TGT(NM) against longer stay by clubbing his previous stay radius of 30 Kms. with TTA/JT to Sh. Manoj Kumar, TGT(NM). At present (14) students are studying in GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, and only one TGT(NM) is working there. Hence, Sh. Anil Kumar TGT(NM) may be relieved only after the joining of the substitute. The representation of the petitioner is disposed of accordingly.
