## **ORDER**

In the matter of:

CWP No. 12368/2025 titled as Yash Pal Singh, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Yash Pal Singh, TGT (NM) previously working in GMS Kathiyara u/c GSSS Sullah has filed CWP No. 12368/2025 titled as Yash Pal Singh, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 30.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

2. "Petitioner is serving as a Trained Graduate Teacher (Non-Medical) at GMS Kathiara, u/c GSSS Sulah, District Kangra. He has taken exception to the office order dated 24.07.2025, whereby he has been transferred to GSSS Jharmanjhri, District Solan. After arguing matter for some time, learned counsel for the petitioner sought permission to withdraw the writ petition, as the petitioner intends to make representation to the Competent Authority. 2. Prayer is accepted. The petition is disposed of as withdrawn. Pending miscellaneous application(s), if any, shall also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 14.08.2025 by the undersigned. During the course of hearing, the petitioner requested that he may be adjusted at GSSS Moondhi or GSSS Gharana or GHS Uchar or GSSS Punner Distt. Kangra against vacancy.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Kathiyara u/c GSSS Sullah, Distt. Kangra to GSSS Jharmajari, Distt. Solan. vide order dated 24.07.2025 with the prior approval of competent authority. One, Smt. Chandresh Katoch, TGT (NM) has been working in GSSS Punner Distt. Kangra since 18.08.2022 and has completed her normal tenure of three years at her present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GSSS Punner Distt. Kangra without TTA/JT vice Smt. Chandresh Katoch, TGT (NM) and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.


