Whereas, Anju Sharma, TGT (NM) preferred CWP No. 9031/2025 titled as Anju Sharma, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Tangroti Khas, Distt. Kangra to GSSS Houridevi, Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 30-05-2025 when the Hon'ble High Court has passed the following orders:-

3. "Though having taken note of the fact that petitioner has already completed normal tenure at present place of posting, there appears to be no justification to interfere in the impugned transfer order as such, same is upheld, however, having taken note of the fact - 3 - that petitioner has recently given birth to a child coupled with the fact that respondent No.6 has given consent to join at Houri Devi, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents/ competent authority to consider and decide pending representation (Annexure P3) expeditiously, preferably, within ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy, which certainly enables an employee to seek transfer on mutual basis as well as medical grounds. Till the time, representation, if any, filed within one week, is decided by the competent authority, petitioner shall not be compelled to join at the transferred station, if not already joined. Pending applications, if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 17-06-2025. She attended the same and submitted her representation in this office on 17-06-2025, vide which She has requested that She may be Adjusted at GSSS Khanyara Khas, Distt. Kangra, vice Sapandeep Sanghera, TGT(NM) on mutual basis, without TTA/JT.

From perusal of record, it has been found that the petitioner has been working at GMS Tangroti Khas, Distt. Kangra, H.P. and under transfer to GSSS Houridevi, Distt. Kangra, H.P. One Smt. Sapandeep Sanghera, TGT(NM) is working in CRSTGSSS Khanyara Khas, Distt. Kangra, H.P. since 21-06-2024. The petitioner has given willingness for her transfer/adjustment to the aforesaid school on mutual basis. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and She is hereby transfer/adjusted at CRSTGSSS Khanyara Khas, Distt. Kangra, vice Smt. Sapandeep Sanghera, TGT(NM) on mutual basis and Smt. Sapandeep Sanghera TGT(NM) is hereby transfer in condonation of short stay from CRSTGSSS Khanyara Khas, Distt. Kangra to GSSS Houridevi, Distt. Kangra, on her own request, without TTA/JT. The representation of the petitioner is disposed of accordingly.
