**ORDER**

In the matter of: CWP No. 9709/2025-titled as Archana Kumari (TGT Med ) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Archana Kumari, TGT (Med.) has filed CWP No. 9709/2025 titled as Archana Kumari V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from GSSS, Dansa Distt. (Sml.) either to GHS, Sathwin, GSSS, Loharli Distt (Hmr.)/GSSS, Balh /GSSS, Paroian Distt. (Una.) GSSS, Patta Distt. (Hmr.). The case was listed before the Hon'ble High Court of H.P. on 17.06.2025 on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation (Annexure P-1) of the petitioner expeditiously, preferably within a period of three weeks from today. Ordered accordingly. Needless to say authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereafter taking note of adverse family circumstances of the petitioner as well as provision contained in Transfer Policy, which certainly enables an employee to seek transfer/adjustment on account of adverse family circumstances. Pending application(s), if any, stand disposed of.*

As per the directions of the Hon'ble High Court, the petitioner was called for a personal hearing, which she attended on 03.09.2025. During the hearing, she stated that since her initial appointment on 30.03.2019, she had been posted at Government High School (GHS), Shilli u/c (GSSS), Bathad, District Kullu. Subsequently, she was transferred to GSSS, Dansa, District Shimla. She further submitted that she has been serving continuously outside her home district since 2019. In view of the above, she has requested to be adjusted against vacancy in either District Hamirpur or District Una.

From the perusal of record, it is found that Smt. Archana Kumari, TGT (Med.) is working at GSSS, Dansa District (Shimla) since 22.08.2022 and has completed normal tenure at his present place of posting. At present one post of TGT (Med.) is lying vacant at GSSS, Balh Distt. (Una.).

Keeping in view the position stated above, representation of the petitioner i.e Smt. Archana Kumari, TGT (Med.) is considered sympathetically and hereby transferred from GSSS, Dansa Distt. (Sml.) to GSSS, Balh Distt. (Una.) against vacancy, without TTA/JT on her own request. The representation of the petitioner is disposed of accordingly.
