**Subject: - Regarding completion of the document verification of in service SMC teacher under C&V category appeared in LDR test conducted by HPBoSE on 22.02.2026 under LDR Quota, the instructions thereof.**

With the prior approval of the Government conveyed vide letter No. EDUC-B015/14/2024 dated 03.09.2025 and No.EDUC-B15/2024-Loose dated 25.10.2025 wherein, it has been approved that the HPBoSE Dharamshala shall conduct LDR test of in service SMC teachers for the post of TGT (Sanskrit), TGT (Hindi) and Drawing Master alongwith other SMC teachers and selected candidates may be recruited as Job Trainee as per Govt. notification issued by Department of Personnel No. PER(AP)-C-B(15)-3/2024, dated 19<sup>th</sup> July, 2025.

In compliance to above the HPBoSE was conducted the LDR test of in service SMC teachers for the post of TGT (Sanskrit), TGT (Hindi) and Drawing Master alongwith other SMC teachers on 22.02.2026 and the result of the same has been declared on 20.03.2026 (Copies are being sent through email).

Therefore, it is directed to constitute a committee at district level under the Chairmanship of Dy. Director of School Education (Elementary) comprising Section Officer (HPF&A), Asstt. Director, Dy. DEO/OSD or any other officer not below than the rank of Principal (School) in case aforesaid officers are not available for verification of the documents of selected candidates under LDR quota duly recommended by the HPBoSE Dharamshala, Kangra for the post of TGT (Sanskrit), TGT (Hindi) and Drawing Master on 27<sup>th</sup> and 28<sup>th</sup> March, 2026. This verification should be completed strictly in accordance with R&P Rules of respective category.

Further, it is also directed to invite the selected candidates through wide publicity i.e. via official website, email, newspaper, telephonically etc. and after completing document verifications the list of the selected candidates alongwith one set of attested documents be sent to this Directorate on the format given below. No individual/separate communication may be made in this regard to the candidates.
