The petitioner has filed present CWP No. 7691/2024 titled as Poonam Thakur V/s State of H.P. in the Hon'ble High Court vide which seek her transfer from GSSS Kharahal Distt Kullu to a station near her village against vacancy/longer stayee on account of adverse family circumstances and medical problem of her daughter. The case was listed before the Hon'ble High Court of H.P. on 09.05.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Consequently, in view of the above, present petition is disposed of with the direction to respondents to consider and decide the pending representation dated 04.03.2025 (Annexure P-4) filed by the petitioner, expeditiously, preferably, within a period of four weeks. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of adverse family circumstances of the petitioner."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for personal hearing on 24.06.2025 and appeared before the undersigned on scheduled date. The petitioner has seek her adjustment either at GSSS Bijhari/ GSSS Parol/ GSSS Bhoranj/GHS Salouni Distt. Hamirpur as she is 100% hearing impaired and her Mother in law is in old age and suffering from many old age ailments.

From the perusal of record, it is found that Smt. Poonam Thakur, TGT (Arts) is working at GSSS Kharahal Distt Kullu since 30.3.2022 and completed her normal tenure at present place of posting. At present post of TGT (Arts) are not lying vacant in ibid mentioned schools, however one Smt. Ambika Kumari, TGT (Arts) working at GSSS Bijhari Distt. Hamirpur who is working since 22.7.2022 and serving within the radius of 30 kilometers.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Poonam Thakur, TGT (Arts) is considered sympathetically and she is hereby adjusted from GSSS Kharahal Distt Kullu to GSSS Bijhari Distt. Hamirpur vice Smt. Ambika Kumari, TGT (Arts) who may further be transferred/adjusted at GSSS Kharahal Distt Kullu, (with TTA/JT to Smt. Ambika Kumari, TGT (Arts). Therefore, representation of the petitioner with the present CWP is disposed of accordingly.

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 7878/2025-titled as Maya Rani, TGT (Arts) V/s State of H.P. on 14.05.2025, the petitioner was called for personal hearing on 24-06-2025 and appeared before the undersigned on scheduled date.
