In the matter of: CWP No. 45/2025 -titled as Anchal, Vs. State of H.P. & others.

Whereas, Smt. Anchal, TGT (NM) preferred CWP No. 45/2025 titled as Anchal, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer from GMS Ghat-Muhath, U/C GSSS Panjain Distt. Mandi to nearby station at her native place in Distt. Una, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 02-01-2025, when the Hon'ble High Court has passed the following orders:-

3. "Accordingly, this writ petition is disposed of with the direction that let representation of the petitioner be decided by the Authority concerned within a period of four weeks from today and the petitioner be transferred from the present place of posting and if possible, be posted either at a station of choice as mentioned in the representation or be adjusted at some other nearby station. While deciding the representation, the Authority should also take into consideration that this is the second order being passed by the High Court for decision of the representation of the petitioner, though this time, the Court is not going into the legality of the earlier rejection, as this Court hopes and expects that a sympathetic view shall be taken by the Authority while deciding the representation of the petitioner. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 22-02-2025. She attended the same and submitted her representation in this office, vide which She has requested that She has completed required tenure at her present place of posting at GMS Ghet-Muheth, U/C GSSS Panjain, Distt. Mandi, H.P and She may be transferred to nearby native place in Distt. Una, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Ghet-Muheth, U/C GSSS Panjain, Distt. Mandi, H.P since, 15-11-2019 and has completed her normal tenure of three years at present place of posting. One Sh. Dharam Chand Atri, TGT(NM) is working in GHS Kuthera-Kherla, Distt. Una, H.P. since 25-02-2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and she is hereby transferred without TTA/JT from Ghet-Muheth, U/C GSSS Panjain, Distt. Mandi, H.P to GHS Kuthera-Kherla, Distt. Una, H.P. vice Sh. Dharam Chand Atri, TGT(NM) against longer stay with TTA/JT to Sh. Dharam Chand Atri, TGT(NM). GMS Ghet-Muheth, U/C GSSS Panjain is a single teacher school. Hence, Smt. Anchal TGT(NM) may be relieved only after the joining of the substitute. The representation of the petitioner is disposed of accordingly.



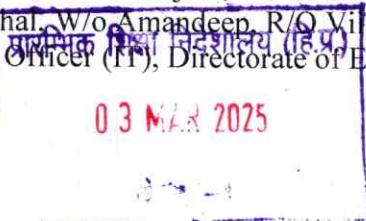
