Regarding implementation of the judgments passed by the Hon'ble High Court in various court cases.

Sir,

It is to inform you that the petitioners involved in the various court cases mentioned herein below have filed petitions in the Hon'ble High Court to consider their services on regular basis instead of contract basis from the date of their initial appointment on the analogy of CWP No. 7602 of 2010 titled as Om Prakash, LPA No. 54/2013 titled as State of Himachal Pradesh & Ors. vs. Om Prakash alongwith LPA No. 21/2013 filed in CWP No. 7602 of 2010 titled as Om Prakash Versus State of H.P. and others & LPA No. 4059/2013 in CWP No. 3144 of 2011-Anju Devi & LPA No. 4060/2013 in CWP No. 3143/2011- Manju Devi and O.A. No. 5561/2015 titled as Tej Ram & ors. vs. State of HP and ors.

The Hon'ble High Court has disposed of the following court cases with the direction to the respondents/competent authority to consider and decide the representations of the petitioners in accordance with law:-

With prior approval of the Govt. vide letter dated 15.05.2024 necessary approval was conveyed for the implementation of above court cases. Meanwhile, due to enactment of "The Himachal Pradesh Recruitment and conditions of Service of Government Employees

Act, 2024” (Act No. 23 of 2025) dated 19th February, 2025, all the above court cases has been rejected.

The matter was once again taken up with the Govt. (Education Secretary) and it has been decided with the consultation of the Advocate General that the judgments passed by the Hon’ble High Court qua deemed regularisation are not covered by “The Himachal Pradesh Recruitment and conditions of Service of Government Employees Act, 2024” (Act No. 23 of 2025).

In view of above, it is directed that the judgments passed by the Hon’ble High Court in r/o LT/Shastri teachers related to your districts, as mentioned/involved in above court cases, be examined as per representations of the petitioners strictly in accordance with rules and regulations and in case the appointments of the above petitioners were made prior to the amendment of R&P Rules or requisitions for recruitment were placed before amendment of R&P Rules and found similarly situated in that event speaking order may be passed accordingly and offer them regular appointment from the date of their initial appointment on contract basis. If during examination of record and scrutiny, it is found that above petitioners who have made representations are not similarly situated then speaking order to this effect may be passed accordingly.

It is further directed that the monetary benefits may be released to the petitioners strictly as per decision of the Hon’ble High Court as well as instructions passed by the finance department vide letter No. Fin-(PR)B(T)-1/2021-loose dated 17.09.2022 and No.Fin-E-1-C-(17)-6/08 dated 31.07.2024. Action in this regard be taken without any delay to avoid further litigation.
