ORDER

Whereas, Smt. Shanti Devi Pandit, Lecturer (School-New) (English) was filed CWP No. 4705/2025 before the Hon'ble High Court regarding seeking her transfer from GSSS Sechunala (Pangi), Distt. Chamba to one of the stations of her choice, on account of her was having completed normal tenure of posting in tribal area.

The case was listed before the Hon'ble Court on 14.5.2025 when the case was disposed of with the following directions:-

“Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation dated 20.1.2025 (Annexure -2) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass detailed speaking order thereupon taking note of transfer policy, which certainly provides that an employee, after his/her having served hard/tribal area, can seek posting at one the station of his/her choice. Liberty is reserved to the petitioner to file appropriate proceedings in appropriate Court of law, if she still remains aggrieved”.

And whereas, as per the direction passed by the Hon'ble High Court on 14.5.2025, petitioner was called to appear in person on dated 17.06.2025. During the course of hearing, petitioner has requested to transfer her one of the stations of her choice i.e. GSSS Andretta/Ghar/Tatehal/Saliana, Distt. Kangra as she is posted in tribal area since 2006. But post is not lying vacant at these stations although vacancy was offered to the petitioner but she has not opted any other vacant post. At last petitioner has requested to transfer her to GSSS Ghar (KGR) where post is going to fall vacant on 31.8.2025 due to retirement of present incumbent.


Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and the petitioner i.e. Smt. Shanti Devi Pandit, Lecturer (School-New) (English) is being transferred from GSSS Sechunala (Chamba) to GSSS Ghar (Kangra) against vacancy being caused due to retirement of present incumbent on 31.08.2025 without TTA/JT as per petitioner request.

Note:- These orders shall come into force on or after 01.09.2025.

With these observations, representation stands disposed of.
