OFFICE ORDER

In the matter of: CWP. No. 15497/2025-titled as Sh. Sanjay Kumar, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Sanjay Kumar, Headmaster, who is presently working in GHS Kalhani, U/C GSSS Sarachi, Distt. Mandi, H.P has filed CWP No. 15497/2025- titled as Sanjay Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Kalhani, U/C GSSS Sarachi, Distt. Mandi, H.P to nearby his native place in Distt Kangra, H.P, against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 24-09-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. Since it is quite apparent from the pleadings as well as documents adduced on record that petitioner has already completed normal tenure at present place of posting, which is claimed to be hard/difficult area, coupled with the fact that Transfer Policy formulated by the Government of Himachal Pradesh, enables an employee to seek transfer from hard/difficult area to soft area on his/her having completed normal tenure i.e. two winters and three summers, this Court sees no impediment in issuing directions to the respondents to consider and decide the pending representation of the petitioner (Annexure P-1) expeditiously, preferably within three weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of fact that mother of the petitioner is 85 years old and there is none to take care of her. Transfer Policy as well as Notification, thereby notifying hard/ difficult/ tribal/ sub cadre area. Pending applications, if any, stand disposed of."

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 28-10-2025. He attended the same and submitted his representation in this office on 28-10-2025, vide which he has requested that he may be transferred from GHS Kalhani, U/C GSSS Sarachi, Distt. Mandi, H.P (hard / difficult area) to nearby his native place in Distt. Kangra, H.P, against vacancy on the ground of adverse family circumstances.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Kalhani, U/C GSSS Sarachi, Distt. Mandi, H.P. since 15-09-2022 and has completed his normal tenure at his present place of posting. At present the post of Headmaster is lying vacant at GHS Jhunga Devi, U/C GSSS Upper Lambagaon, Distt. Kangra, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GHS Kalhani, U/C GSSS Sarachi, Distt. Mandi, H.P. to GHS Jhunga Devi, U/C GSSS Upper Lambagaon, Distt. Kangra, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.

OFFICE ORDER

In the matter of: CWP. No. 16223/2025-titled as Sh. Ajay Singh Rana, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Ajay Singh Rana, Headmaster, who is presently working in GHS Bhandar, U/C GSSS Manjheer, Distt. Chamba, H.P has filed CWP No. 16223/2025- titled as Ajay Singh Rana, Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Bhandar, U/C GSSS Manjheer Distt. Chamba to nearby his native place in Distt Kangra, H.P, against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 15-10-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. True it is that it is the sole prerogative of the employer to post an employee at a particular station, but once transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer on the ground of adverse family circumstances, this Court having taken note of serious illness of father of the petitioner, as is evident from the averments contained in the petition as well as documents annexed therewith, sees no High Court of H.P. impediment in issuing direction to the respondents to consider and decide the pending representation (Annexure P-1) of the petitioner expeditiously, preferably within a period of three weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order, taking note of transfer policy formulated by the Government of Himachal Pradesh as well as observations made hereinabove. Pending applications, if any also stand disposed of"

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 28-10-2025. He attended the same and submitted his representation in this office on 28-10-2025, vide which he has requested that he may be transferred from GHS Bhandar, U/C GSSS Manjheer, Distt. Chamba, H.P (tribal area) to nearby his native place in Distt. Kangra, H.P, against vacancy on the ground of adverse family circumstances.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Bhandar, U/C GSSS Manjheer, Distt. Chamba, H.P. since 19-09-2022 and has completed his normal tenure at his present place of posting. At present the post of Headmaster is lying vacant at GHS Bharwana, U/c GSSS Saliana, Distt. Kangra, H.P. The petitioner has given willingness for his transfer to the aforesaid school against vacancy. Keeping in view of the above position, the representation of the petitioner is considered and he is hereby transferred from GHS Bhandar, U/C GSSS Manjheer, Distt. Chamba, H.P. to GHS Bharwana, U/c GSSS Saliana, Distt. Kangra, H.P, against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.



ORDER


In the matter of:- CWP No. 7522/2025-titled as Raman Kumar, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP in the Hon'ble High Court vide which sought his adjustment at one of the station of his choice. The present CWP was listed before the Hon'ble High Court of H.P. on 02.09.2025, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 01-10-2025 and appeared before the undersigned on the said date. During the hearing, the petitioner, Sh. Raman Kumar, TGT (Arts), submitted fresh representation and requested that keeping in view his adverse personal and family circumstances requested for adjustment in any school under complex GSSS Marhana/GSSS Bhareri/GSSS Kot/ within Education Block Ghumarwin-I Distt. Bilaspur against longer stayee.

From the perusal of the record, it is found that Sh. Raman Kumar, TGT (Arts), was posted at GSSS Marhana, District Bilaspur, w.e.f. 08.09.2022, and his transfer order was issued to GHS Ghial under GSSS Namhol, District Bilaspur, vice Sh. Ramesh Kumar, TGT (Arts), on a vice-versa basis by clubbing the petitioner's previous posting stay. Sh. Raman Kumar, TGT (Arts), has already joined his duties at GHS Ghial under GSSS Namhol, District Bilaspur, on 07.05.2025. Further, Sh. Raman Kumar, TGT (Arts), is suffering from 40% permanent disability. The institution, i.e., GHS Ghial under GSSS Namhol, District Bilaspur, is classified as a soft area within District Bilaspur, where 65 students are enrolled. As per the provisions contained in the Comprehensive Guidelines (Principles)-2013 for regulating the transfer of State Government employees, Clause 5.3 specifically provides that "as far as possible, officers/officials with 60% and above physical disability should be given a station where bus service is available." Furthermore, the Hon'ble High Court of Himachal Pradesh, in CWP No. 2734/2024, titled Monika Katna vs. State of H.P. & others, dated 06.06.2025, has held that the clubbing of stay for the purpose of transfer of employees of the Education Department is absolutely legal and valid, and not contrary to Clause-10 of the Transfer Policy of the State Government dated 10.07.2013.

Keeping in view, the above facts and circumstances, the case of the petitioner for adjustment cannot be considered at this stage as the petitioner has already been joined at transferee school i.e. GHS Ghial u/c GSSS Namhol Distt. Bilaspur. Hence, the representation of the petitioner is hereby rejected and stands disposed of on the grounds that the petitioner having short stay further he is presently posted at a soft area station and, in the larger interest of the students, his services are essentially required at GHS Ghial u/c GSSS Namhol Distt. Bilaspur. It is further considered that the transfer of the petitioner at this stage would adversely affect the studies of the students during the mid-academic session. All the concerned are intimated accordingly.
