In the matter of: CWP No. 19942/2025- titled as Sunil Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Sunil Kumar, TGT(NM) presently working in GMS Thanali u/c GSSS Seri Banglow, Distt. Mandi has filed CWP No. 19942/2025 titled as Sunil Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GMS Thanali u/c GSSS Seri Banglow, Distt. Mandi to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 17.12.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWPs with the following directions/Order :-

"Looking to the limited grievance of the petitioner, but without examining the merits of the matter, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation dated 28.10.2025 (Annexure P-5) of the petitioner in accordance with law and applicable transfer policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 16.01.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Thanali u/c GSSS Seri Banglow, Distt. Mandi to GSSS Hatgarh or GMS Padsal u/c GSSS Kapahi or GSSS Slapper or GMS Chalouni u/c GSSS Jarol or GMS Panyas u/c GSSS Jaidevi or GMS Shadhala u/c GSSS Katindhi, Distt. Mandi.

After perusal of the relevant record, it is revealed that the petitioner has been working in GMS Thanali u/c GSSS Seri Banglow, Distt. Mandi since 07.10.2022 which is a soft area and he has completed his normal tenure at his present place of posting. The petitioner is a TGT(NM) which comes under State cadre post and can be posted anywhere in the state as per requirement. The petitioner in his representation has specified for his adjustment in GSSS Hatgarh or GMS Padsal u/c GSSS Kapahi or GSSS Slapper or GMS Chalouni u/c GSSS Jarol or GMS Panyas u/c GSSS Jaidevi or GMS Shadhala u/c GSSS Katindhi, Distt. Mandi. However, as per Comprehensive Guidelines Principles-2013 there is no such provision that allows a government employee serving in soft area to specify stations of his choice for adjustment. Further, at present, vacancies are not available in the above-mentioned schools where petitioner requested for transfer, hence the request of the petitioner cannot be acceded.

The representation of the petitioner is disposed of after due consideration.

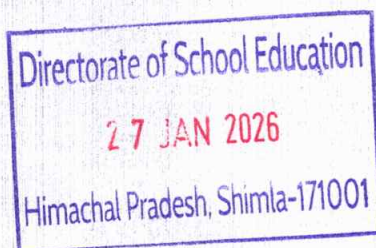
