“Office Order”

1. COPC NO. 1449/2025 in CWP No. 12401/2025 Satish Kumar TGT(NM) V/s State of H.P.
2. COPC No. No. /2025 in CWP No. 903/2025 Rajmal & ors V/ s State of H.P.
3. COPC No. /25 in CWP No. 4401/2023 titled as Kuldeep Singh TGT(NM) V/s State of H.P.
(Reg. fix the pay of the petitioners from the eligible date of period at minimum revised pay scale (60%) of Rs. 38100)

Whereas, the petitioner has filed the present Civil Writ petition thereby seeking the relief to issue the direction to the respondents to pay revised emoluments to petitioners from the initial appointment i.e. (60%) of Rs. 38100/- in terms of the HP Civil Service (Revised pay) rules, 2022 effective from 01.01.2016.

The said case was listed before the Hon'ble High Court on different dated when the Hon'ble High Court has directed that the instant writ petition(s) are disposed of by directing the respondents/competent authority to consider and decide the aforesaid representation(s) of the petitioner(s), on main case in accordance with law, within a period of six weeks from today. The order so passed be also communicated to the petitioner(s). Pending miscellaneous application(s), if any, shall also stand disposed of.

On perusal of record, it is found that the petitioners in above said CWP's have been appointed on contract basis in various year on contractual emoluments equivalent to minimum of pay band plus grade pay and have further been regularized. Now, as per their representation petitioners have requested to grant the revised pay scale after issuance of notification dated 03.01.2022, i.e. (60%) minimum of Rs. 38100/- w.e.f. 01.01.2016.

Whereas, as per the Govt. has notified Revised Pay Scale rules -2022 vide notification dated 03.01.2022. Accordingly to Clause 2.1 these rules, “they shall apply to all the person appointed on regular basis to the service and post in connection with the affairs of the State of HP and whose pay is debited to the Consolidated fund of State of HP but as per Clause 2.2 they shall not apply to the (g) person employed on contract basis. Revised emoluments for contract employees were notified and made applicable w.e.. 01.01.2022 and contract employee are fixed & 60% of minimum of pay scale (at lower grade, in the regular scale). Further the notification for the grant of arrear on account of pay revision is issued on dated 17.09.2022 by the State of H.P. qua regular employees which was not applicable for contract period.

Whereas, the judgment passed in CWP No. 8148/2022 titled as Yashwant Kumar & Ors. V/s State of H.P. has been assailed by Health Department way of filing LPA. Further, CWP No. 2056/2023 titled as Ghanshyam Dass was implemented vide this Directorate office order dated 18.06.2025 as per approval of Govt. letter dated 17.06.2025 subject to final outcome of LPA.

In view of the Hon'ble High Court orders and as per approval conveyed by the Govt. vide their letter dated 17.06.2025 & 01.10.2025, the petitioner are allowed the benefit of revised emoluments (60 %) minimum of revised pay scale in terms of revised notification from 01.01.2016 subject to final outcome of LPA. The Principal of concerned school where the petitioner is presently working is hereby directed to fix the pay of the petitioners for the period they served on contract basis at the (60%) minimum of revised pay scale band + Grade pay alongwith such hike to which they are entitled to in terms of revised notification from 01.01.2016 to till their regularization subject to final outcome of LPA being filed by State and other legal remedies. However, an undertaking to this effect may be obtained from the petitioner that the overpayment if any, found, in later stage shall be recovered from them accordingly. The entry be also made in the service book of individual concerned. May inform the parties accordingly.
