**ORDER**

In the matter of: CWP No. 20568/2025 titled as Narender Singh, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Narender Singh, TGT (NM) presently working at GSSS Nanhar, Distt. Shimla has filed CWP No. 20568/2025 titled as Narender Singh, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that he may transferred from GSSS Nanhar, Distt. Shimla to one of the stations of his choice in Distt. Bilaspur. The case of the petitioner was listed before the Hon'ble High Court on 29.12.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

***“Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner dated 23.10.2025 (Annexure P-3) in accordance with law and applicable transfer policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.”***

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 16.01.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Nanhar, Distt. Shimla to GHS Balghar or GSSS Salwar or GSSS Jejwan or GSSS Marotan or GSSS Bheri, Distt. Bilaspur against vacancy or against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working at GSSS Nanhar, Distt. Shimla since 10.05.2023 and has completed five years of tenure in Distt. Shimla. At present, one post of TGT (NM) is lying vacant at GSSS Salwar, Distt. Bilaspur.

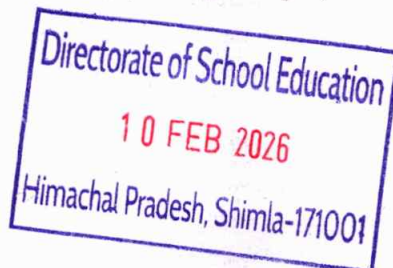
Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GSSS Nanhar, Distt. Shimla to GSSS Salwar, Distt. Bilaspur without TTA/JT as per his request.
