ORDER

Whereas, Sh. Rajesh Kumar, TGT (NM) previously working in GMSSS Sullah, Distt. Kangra has filed CWP No. 11567/2025 titled as Rajesh Kumar, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 18.07.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Consequently, in view of the above, this Court, without interfering in the impugned order dated 14.07.2025, deems it fit to dispose of the present petition reserving liberty to the petitioner to file representation within two days for his adjustment at a convenient station/place, which shall be decided by the competent authority within ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders taking note of Transfer Policy, which certainly provides certain concessions to employee, who has already served hard/tribal area. Till the time, representation, as detailed herein above, is not decided in terms of instant order, petitioner shall not be compelled to join at transferred station in terms of impugned transfer order. Pending applications, if any, stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 11.08.2025 by the undersigned but the petitioner attended the personal hearing on 04.08.2025. During the course of hearing, the petitioner requested that he may be adjusted at GHS Kand u/c GSSS Dari or GHS Sukkar u/c GSSS Mandal or GSSS Moondhi or GSSS Rajhoon, Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMSSS Sullah, Distt. Kangra to GSSS Seikothi, Distt. Chamba in view of CWP No. 8934/2025. One, Smt. Anchal Dhiman, TGT (NM) has been working in GHS Sukkar u/c GSSS Mandal, Distt. Kangra since 04.10.2023 and her previous place of posting was GSSS Kasba Narwana where she worked 30.04.2021 to 04.10.2023 and has completed her normal tenure of three years within the radius 30 KM.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted at GHS Sukkar u/c GSSS Mandal without TTA/JT vice Anchal Dhiman, TGT (NM) and vice versa with TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.

Whereas, Sh. Ravinder Kumar, TGT(NM) previously working in GMS Magroo u/c GSSS Aloh, Distt. Kangra has filed CWPNo.9827/2025 titled as Sh. Ravinder Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 19.06.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Having taken note of the fact that petitioner has already completed normal tenure of posting at present place of posting, though this Court finds no reason to interfere with the impugned transfer order, but having taken note of the fact that petitioner has already filed representation dated 11.06.2025 (Annexure P-2) to the competent authority, praying therein for his adjustment at a convenient station, this Court deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation (Annexure P-2) of the petitioner expeditiously, preferably within a period of ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass appropriate order, taking note of transfer policy framed by the Government of Himachal Pradesh, which certainly enables an employee to seek transfer/adjustment at a convenient station on account of adverse family circumstances. Till the time representation, if any, filed by the petitioner, is not decided by the competent authority, petitioner shall not be compelled to join at the transferred station. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.07.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be adjusted at GMS Sai u/c GSSS Charara, Distt. Una or GMS Tikkar u/c GSSS Pirsaluhi, Distt. Kangra.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Magroo u/c GSSS Aloh, Distt. Kangra to GMS Hinner u/c GSSS Gaura, Distt. Solan vice Sh. Sandeep Chauhan, TGT(NM) with TTA/JT vide this Directorate letter dated 06.06.2025 with the prior approval of the competent authority. At present, vacancies are not available in the above-mentioned schools where petitioner requested for transfer. One post of TGT(NM) is lying vacant at GMS Koon u/c GSSS Delgi, Distt. Solan. The cadre of the post of TGT(NM) is state cadre and can be transferred/posted any where in the state as per transfer policy

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered and he is hereby adjusted at GMS Koon u/c GSSS Delgi, Distt. Solan against vacancy.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
