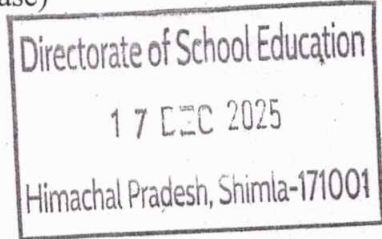

**ORDER**

**Whereas,** Sh. Uttam Chand, Lecturer (School-New) (English) was filed CWP No. 17107/2025 before the Hon'ble High Court for seeking direction to the respondent to consider and decide his pending representation wherein he has prayed for his transfer from GSSS Pangna, Distt. Mandi to GSSS Kutahchi, Distt. Mandi, as pleaded that he has already completed his normal tenure of posting at present place of posting.

The case was listed before the Hon'ble Court on 03.11.2025 when the case was disposed of with the following directions:-

**“Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the petitioner’s representation dated 14.08.2025 (Annexure P-2) in accordance with law and applicable Transfer Policy, within a period of four weeks from today. The decision so arrived at shall be communicated to the petitioner.”**

**And whereas,** as per directions passed by the Hon'ble High Court, petitioner was called to appear in person on dated 15.12.2025. During the course of hearing, petitioner has requested that he has completed his normal tenure at GSSS Pangna (Mandi) and due to adverse family circumstance he is unable to continue at GSSS Pangna (Mandi) and further requested to transfer him to GSSS Kutahchi (Mandi) against vacancy.

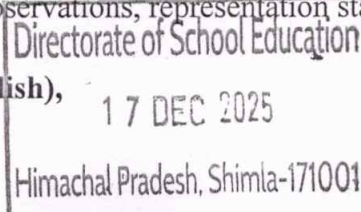
**And whereas,** while examined his representation it is found that his stay is complete at GSSS Pangna (Mandi) and there is two sanctioned post of Lecturer (English) and both are filled but only one post of Lecturer (English) is sanctioned at GSSS Kutahchi (Mandi) which is lying vacant and student enrollment is 37 and there is requirement of Lecturer (English).

**Now therefore,** after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically and the petitioner i.e. Sh. Uttam Chand, Lecturer (School-New) (English) is being transferred from GSSS Pangna (Mandi) to GSSS Kutahchi (Mandi) against vacancy without TTA/JT as per petitioner request.

With these observations, representation stands disposed of.
