ORDER

In the matter of:- CWP No. 189/2026-titled as Uttam Ram, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 189 of 2026 in the Hon'ble High Court vide which sought his transfer from GHS Chhawara u/c GMSSS Bajora Distt. Kullu to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on 05.01.2026, on this day Hon'ble Court has passed order/judgment.

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 24-01-2026 and appeared before the undersigned. During the hearing, the petitioner, Sh. Uttam Ram, TGT (Arts), submitted fresh representation and stated that he is working at GHS Chhawara u/c GMSSS Bajora Distt. Kullu and he is 55 % PHH so that requested for transfer/adjustment at GHS Bhulang Distt. Kullu, on account of completion of normal tenure as well as he is 55% PH/disabled.

From the perusal of the record, it is found that Sh. Uttam Ram, TGT (Arts), has been working at from GHS Chhawara u/c GMSSS Bajora Distt. Kullu since 13.10.2022 and he has completed his normal tenure at present place of posting wherein 46 students are enrolled. Further, at present one post of TGT (Arts) is lying vacant at GHS Bhulang Distt. Kullu wherein 152 students are enrolled, which also falls within the choice station of the petitioner.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Sh. Uttam Ram, TGT (Arts) posted at GHS Chhawara u/c GMSSS Bajora Distt. Kullu is hereby transferred/adjusted at GHS Bhulang Distt. Kullu against vacancy without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.
