Subject:- Tentative promotion panel of TET pass in-service C&V (person with Disability) to be considered for promotion to the post of TGT (Arts).

Sir/Madam,

As per the provision contained in existing R & P Rules of TGTs dated 06.06.2024 & 17.02.2025, 10% post of TGT (Arts) is meant for in-service C&V teachers who possess the requisite qualification of TGT (Arts) and the Department is going to promote these teachers amongst 10% quota as pertained in the R&P Rules whereas 4% quota is reserved for the person with Disability (PwDs). Hence tentative promotion panel of TET (Art) In accordance with these provisions, the Department proposes to promote eligible in-service C&V teachers against the said promotional quota, subject to fulfillment of the prescribed eligibility conditions and availability of vacancies.

In this regard, it is submitted that, a tentative promotion panel of TET qualified in-service C&V teachers(PwDs) possessing B.A/B.Com with B.Ed. qualification and having completed five years of regular service as C&V teacher as on 31.12.2025, has been prepared strictly on seniority of appointment.

You are, therefore directed to verify the present status of all these C&V teachers whether they are still working in the same cadre and also bring it to the notice of all the individual concerned and other C&V teachers appointed in the previous/same year who possess the requisite qualification of TGT (Arts). Objections, as well as left out cases can submit their objections/fresh cases to this Directorate up to **31.01.2026** and thereafter no objections/case shall be entertained and the final promotion panel will be prepared accordingly.

You are further intimated that in-service Language Teachers and Shastris possessing B.Ed. and TET qualifications (LT/Shastri) have been re-designated as TGT (Hindi) and TGT (Sanskrit) by the Government vide notification dated 23.08.2022, without any change in their existing pay scale. Simultaneously, the Recruitment and Promotion (R&P) Rules for these categories were amended on 18.02.2025.

It is also intimated that the post of TGT (Hindi) & TGT (Sanskrit)


is District cadre whereas, the post of TGT (Arts) is State cadre, hence, these teachers are being considered for promotion to the post of TGT (Arts) subject to the condition that they fulfill the requisite qualification of TGT (Arts).

Their seniority for promotion to the post of Headmaster/PGT will be considered strictly w.e.f. the date of promotion/joining as TGT (Arts).

The tentative promotion panel is available on the departmental website of this Directorate i.e. <https://himachal.nic.in/dse>. Objections will also be received through E-mail promotiontgt.e2@gmail.com or by hand besides registered post etc.

Note:-1. It shall be ensured that the contractual service rendered by the C&V shall not be counted towards promotion for fulfilling the condition of a minimum of five years of regular service.

2. All the Dy. DSE, & Individual concerned are directed to download the same from the departmental website of this Directorate. No hard copy is being supplied to anyone.
