"ORDER"

Whereas the petitioner Smt. Shanti Devi, Lect./Lect.(SN) Biology is working at GSSS Shivabadar, Distt. Mandi w.e.f. 28.07.2021 & as such her stay is complete. Feeling aggrieved she filed CWP No 15010/2025 titled as Shanti Devi Vs State of H.P before the Hon'ble High Court. This petition was listed before Hon'ble High Court on dated 17.09.2025 when the same was finally disposed with the directions to respondents as under:-


"Petitioner is presently serving as Lecturer School New Biology at Government Senior Secondary School Shiva-Badar, District Mandi. Her grievance is that she has repeatedly preferred representations viz. on 05.01.2024 and 14.08.2025 (part of Annexure P-4) seeking her transfer from present place of posting to a station of her convenience on medical ground as she is suffering from certain cardiac problems but the said representations have not been considered and decided till date, even though the same were forwarded by the Principal to respondent No.2/competent authority on 10.01.2024. Learned counsel for the petitioner submitted that the petitioner would be content, in case, respondent No.2/competent authority is directed to consider and decide the aforesaid representations of the petitioner, in accordance with law, within a time bound manner. Learned Additional Advocate General has no objection to this prayer.

Having regard to the above submissions, the instant writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representations of the petitioner, in accordance with law, within a period of two weeks from today positively. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of."

And whereas upon passing of above directions, the representation of petitioner has been perused and examined and it has been observed that she has requested for her adjustment either at GSSS Gagai, (Mandi)/ DIET Mandi, (Mandi)/ GSSS Pairi, (Mandi) against longer stayee.

And whereas as per direction passed by the Hon' ble High Court as above, the applicant was called to appear in this office for personal hearing on 15.10.2025 and was present on this date. During the course of hearing the applicant has pleaded that her relief as though the petitioner suffering from heart disease and difficult to serve at the present place of posting.

And whereas, now therefore, after taking into account the above discussed facts and circumstances of the case, the request of the petitioner has been considered and the petitioner i.e Smt. Shanti Devi, Lect./Lect.(SN) Biology is being adjusted/ transferred to GSSS Gagai, Distt. Mandi against vacancy being cause due to promotion of present incumbent with the condition that this order shall come into force on or after promotion of present incumbent. Accordingly representation in r/o petitioner i.e Smt. Shanti Devi, Lect./ Lect. (SN) Biology stand disposed.
