Terms and conditions for re-employment of employees of PSUs.

Sir,

The undersigned is directed to refer to this department's letter of even No. dated 07.03.2024, regarding fixation of emoluments and terms and conditions of the retirees reengaged in the Board/Corporation/PSUs/Autonomous Bodies.

Autonomous Bodies are hiring the services of the retirees as per the provisions of the HPFR. 2009, where the post of the respective category is not available. The question relating to fixation of emoluments and terms and conditions of such cases was engaging the attention of the government for past some time.

For the reasons of economy and in the public interest, the Board/ Corporation/
PSUs/Autonomous Bodies may consider hiring/engaging retired persons as per the Rule-131 of the HPFR, 2009, where the post of the respective category is not available, on the following terms and conditions:-

(A). Nomenclature and Emoluments:-

1.	Tenure	The tenure of engagement shall be for a period as determined by the Board/Corporation/PSUs/Autonomous Bodies and will be effective from the date of issue of the orders. But in no case it should exceed more than one year at a time in case of Class-I to IV retirees except in the case of specialized services termed as "Consultants". Provided that the Board/Corporation/PSUs/Autonomous Bodies can terminate this engagement even before the expiry of the above period, in case the services of the incumbents are not required.	
2.	TA/DA	He/She shall be entitled to TA/DA as is admissible to an outsourced person, if any.	
3.	Leave	He/She shall be entitled to Leave as is admissible to an outsourced person, if any.	
4.	Medical Facilities/ Expenses	As per prevailing system in the concerned Board/Corporation/PSUs/ Autonomous Bodies etc.	
5.	Accommodation	As per prevailing system in the concerned Board/Corporation/PSUs/ Autonomous Bodies etc.	

- (C). All the expenditure to be incurred on fixed emoluments on hiring of such manpower is to be borne under SOE "outsourcing" only.
- (D). The Board/Corporation/PSUs/Autonomous Bodies may ensure that prior concurrence of the Finance Department on each such proposal may be obtained and no such engagement be made at their own level in any case.

- (E). Such engagement can be terminated before the expiry of specified period in case conduct and performance of the incumbents are not found satisfactory by giving prior notice of 15 days.
