OFFICE ORDER

In the matter of: CWP No. 270/2026-titled as Bhupinder Kumar, Vs. State of H.P &Others.

Whereas, Sh. Bhupinder Kumar, Lect. Physics preferred CWP No. 270/2026 titled as Bhupinder Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Barot, Distt. Mandi to nearby his native place in Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 05-01-2026 when the Hon'ble High Court has passed the following orders:-

3. "Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/Competent Authority to consider and decide the aforesaid representations of the petitioner in accordance with law and as per applicable notification/policy within a period of four weeks from today. The decision so taken be also communicated to the petitioner. Pending miscellaneous application(s), if any, also stands disposed of."

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 05-03-2026. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred from GSSS Barot, Distt. Mandi, H.P hard area to soft area nearby his native place in Distt. Mandi or Distt. Kangra, H.P, against vacancy/ longer saty.

In the perusal of the record, it is found that the petitioner is working at GSSS Barot, Distt. Mandi, H.P since 21-03-2023, which is hard area and has completed his normal tenure at his present place of posting. One post of Lect. Physics is going to be vacant due to retirement of present incumbent on 31-03-2026 at GSSS Baijnath, Distt. Kangra, H.P Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Barot, Distt. Mandi to GSSS Baijnath, Distt. Kangra, H.P, against vacancy being caised due to retirement of present incumbent on 31-03-2026. These orders will be implemented after the retirement of present incumbent on 31.03.2026. The representation of the petitioner is disposed of accordingly.
