ORDER

The petitioner has filed present CWP No. 7229/2025 titled as Gyar Singh Negi V/s State of H.P. in the Hon'ble High Court against his transfer order issued on dated 27.04.2025 from GMS Ghutanpur u/c GSSS Battamandi (SMR) to GSSS Muglawala, GHS Kuner Dhamon u/c GSSS Gorkhuwala, GHS Kalatha u/c GSSS Killor (SMR). The case was listed before the Hon'ble High Court of H.P. on 02.5.2025, on this day Hon'ble Court has passed order. The Operative portion of the present CWP judgement is as under:-

"Precisely, the grouse of the petitioner, as has been highlighted in the petition and further canvassed by Ms. Rajni Gandhi, learned counsel representing the petitioner is that though petitioner has already served in hard area, but yet he has been ordered to be transferred to hard area. While referring to Clause 2 of the impugned transfer order, Ms. Gandhi states that since petitioner has already served sub-cadre/hard/tribal/difficult area, he otherwise cannot be relieved against such area."

On the perusal of record, it is revealed that petitioner Sh. Gyar Singh Negi, TGT (Arts) is working at GMS Ghutanpur u/c GSSS Battamandi (SMR) since 30.8.2022 and has not completed his normal tenure at his present place of posting but serving within the radius of 30 Kms. and petitioner has already served in hard area at GSSS Halan (SML) and requested to adjust either at against vacancy being caused due to retirement of present incumbents. At present one post of TGT (arts) is lying vacant at GHS Kuner Dhamon u/c GSSS Gorkhuwala, District Sirmour.

Keeping in view the position stated above, representation of petitioner is considered sympathetically and Sh. Gyar Singh Negi, TGT (Arts) is hereby transferred from GMS Ghutanpur u/c GSSS Battamandi (SMR) to GHS Kuner Dhamon u/c GSSS Gorkhuwala, against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
