ORDER

Whereas, Sh. Rajeev Kumar, Lecturer (School-New) (English) has filed CWP No. 8739/2025 before the Hon'ble High Court wherein seeking direction to respondent to consider and decide his pending representation whereby he has prayed for his transfer from GSSS Kharkari (BLP) to one of the station of his choice i.e. GSSS Matahani/Patlandar/Kakkar (HMR) on the ground that his son is 70% disabled and there is no one to take care of him.

The case was listed before the Hon'ble Court on 26.05.2025 when the case was disposed of with the following directions:-

"Careful perusal of averments contained in the petition, which is duly supported by way of affidavit clearly reveals that petitioner has already completed normal tenure of posting at present station and his minor son is disabled to the extent of 70%, coupled with the fact that transfer policy formulated by the Government of Himachal Pradesh enables an employee to seek transfer/adjustment at a convenient station on the ground of adverse family circumstances, this Court without going into the merits of the case, deems it fit to dispose of the present petition, with the direction to respondents to consider and decide his pending representation (Annexure P-3) expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of transfer policy, which certainly enables an employee to seek transfer or adjustment at a convenient station, on account of adverse family circumstances".

And whereas, as per the direction passed by the Hon'ble High Court petitioner was called for personal hearing on 14.08.2025. During the course of hearing, petitioner has submitted his fresh representation wherein he has requested that his son is suffering from a rare mental disorder called Autism Spectrum Disorder (70% disabled) and further requested to transfer him to GSSS Mehal/GSSS Amroh/GSSS Matahani, Distt. Hamirpur.

And whereas, while examined his representation it is found that at present post of Lecturer (English) is not lying vacant at GSSS Matahani/Patlandar/Mehal/Amroh, Distt. Hamirpur therefore petitioner cannot be transfer to these stations as it may invite unwanted litigation. However, post is lying vacant at GSSS Kakkar (HMR).

Now therefore, after taking into account of the above facts and circumstances of the case, representation of petitioner is considered sympathically on medical grounds on his son and the petitioner i.e. Sh. Rajeev Kumar, Lecturer (School-New) (English) is being transferred from GSSS Kharkari (BLP) to GSSS Kakkar (HMR) against vacancy without TTA/JT as per petitioner request.

With these observations, representation stands disposed of.
