ORDER

In the matter of: CWP No. 1796 of 2026 titled as Des Raj versus State of H.P. & others.

Whereas, Sh. Des Raj, Peon, presently working at GSSS Sherpur, District Chamba, H.P., filed CWP No. 1796 of 2026 titled Des Raj versus State of H.P. & others before the Hon'ble High Court of H.P. seeking relief that he may be transferred to GSSS Sechunala, District Chamba, keeping in view his disability. The case of the petitioner was listed before the Hon'ble Court on 10.02.2026, when the Hon'ble Court disposed of the above petition with the following directions:

"Accordingly, respondents are directed to consider and decide the representation of the petitioner, Annexure P-2, dated 26.12.2025 expeditiously, preferably within a period of two days from today in accordance with law.

It is made clear that this court has not expressed any opinion on the merits of the case and the decision on the representation shall be taken by the authority concerned strictly in accordance with law."

In order to comply with the directions of the Hon'ble High Court, the Deputy Director of School Education (Secondary), Chamba was requested to provide the vacancy position of Peon at GSSS Sechunala and nearby schools. As per the report of DDSE(S), Chamba, all the three sanctioned posts of Peon are filled and there is no vacancy of Peon at GSSS Sechunala. The DDSE (S), Chamba also reported that there is no vacant post of Peon in nearby schools of GSSS Sechunala or in Pangi Valley.

Subsequently, the DDSE (S), Chamba was requested to obtain other choices of stations from the petitioner, Sh. Des Raj. The petitioner opted for transfer to GHS Sahali and GMS Chask in District Chamba. However, as per the report of DDSE (S), Chamba dated 09.03.2026, no post of Peon is vacant at these stations either. It was further reported that one post of Peon has become vacant at GSSS Purthi due to the demise of the incumbent Peon and the petitioner could be transferred there.

Therefore, keeping in view the above facts and considering the representation of the petitioner sympathetically in view of his physical disability, Sh. Des Raj, Peon, is hereby transferred from GSSS Sherpur, District Chamba to GSSS Purthi, District Chamba against the vacant post without TTA/JT.

Accordingly, the representation of the petitioner stands disposed of after due consideration. All concerned be informed accordingly.
