OFFICE ORDER

In the matter of: CWP. No. 19272/2025-titled as Sh. Shashi Bhushan, Headmaster Vs. State of H.P. & Others.

Whereas, Sh. Shashi Bhushan, Headmaster, who is presently working in GHS Kuther, U/C GSSS Jadera, Distt. Chamba, H.P has filed CWP No. 19272/2025- titled as Shashi Bhushan. Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GHS Kuther, U/C GSSS Jadera, Distt. Chamba, H.P to nearby his native place in Distt Kangra, H.P, against vacancy. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 05-12-2025, when after hearing the matter the Hon'ble High Court has disposed of the same with the following directions:-

"3. Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the aforesaid representation of the petitioner, in accordance with law, within a period of four weeks from today. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any, shall also stand disposed of"

In compliance to the directions of Hon'ble High Court Himachal Pradesh, the petitioner was called for personal hearing on 16.01.2026. He attended the same and submitted his representation in this office on 16.01.2026, vide which he has requested that he is on verge of retirement on 30-11-2027. So, he may be transferred from GHS Kuther, U/C GSSS Jadera, Distt. Chamba, H.P. to nearby his native place in Distt. Kangra, against vacancy, being caused due to retirement of present incumbent on 31-03-2026.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Kuther, U/C GSSS Jadera, Distt. Chamba, H.P. since 09-12-2021 and has completed his normal tenure at his present place of posting. The petitioner is going to be retire on 30-11-2027. He has given three stations of his choice in District Kangra, in which one post of Headmaster is being caused vacant due to retirement of present incumbent at GHS Kulthi, U/C GSSS Daulatpur, Distt. Kangra on 31-03-2026. Keeping in view the above facts and circumstances the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GHS Kuther, U/C GSSS Jadera, Distt. Chamba, H.P to GHS Kulthi, U/C GSSS Daulatpur, Distt. Kangra, against vacancy being caused due to retirement of present incumbent on 31-03-2026. These orders will be implemented after retirement of present incumbent. The representation of the petitioner is disposed of accordingly.
