## **ORDER**

In the matter of:

CWP.No.13813 /2025- Sh. Anurag Sharma, TGT(NM) Vs. State of H.P. and others.

Whereas, Sh. Anurag Sharma, TGT(NM) presently working in GSSS Seri Chehatigarh, Distt. Mandi has filed CWP. No. 13813/2025 titled as Sh. Anurag Sharma Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be transferred from GSSS Chehatigarh, Distt. Mandi to one of the stations of his choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 27.08.2025 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order:-

"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition with direction to the respondents/competent authority to decide the pending representation having been filed by the petitioner (Annexure P-2) expeditiously, preferably, within four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass a speaking order thereupon taking note of transfer policy, which enables an employee to seek transfer from hard area to soft area on the ground of couple case. Pending applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 15.12.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GSSS Seri Chehatigarh, Distt. Mandi to GMS Upper Barot u/c GSSS Paunta or GMS Bakarta u/c GSSS Rakoh or GSSS Chandesh or GMS Gaunta u/c GSSS Jamni, Distt. Mandi, against vacancy being couple case.

After perusal of relevant record, it is revealed that the petitioner has been working in GSSS Seri Chehatigarh, Distt. Mandi since 14.10.2022 and has completed his normal tenure of three years. In the transfer policy at clause No. 5.4 it has been mentioned that in case wife and husband both are working under the State Government, efforts should be made to post them at one place or near places as far as possible, subject to vacancy. At present, one post of TGT(NM) is lying vacant at GMS Gaunta u/c GSSS Jamni, Distt. Mandi.

Therefore, keeping in view the clause mentioned in the transfer policy elaborated hereinabove in the above para, Sh. Anurag Sharma, TGT(NM) is hereby transferred from GSSS Seri Chehatigarh, Distt. Mandi to GMS Gaunta u/c GSSS Jamni, Distt. Mandi against vacancy being couple case on his own request without TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
