ORDER

In the matter of: CWP No. 1015/2024-titled as Santosh Kumar a/w CWP No. 1016/2024 to 1017/2024, 1019/2024 to 1027/2024, 1031/2024 to 1034/2024, 1036/2024 to 1068/2024, 1117/2024 to 1122/2024, 1125/2024 to 1138/2024, 1141/2024 to 1154/2024, 1172/2024, 1175/2024 to 1198/2024, 1200/2024 to 1219/2024, 1229/2024 to 1271/2024, 1281/2024 to 1290/2024, 1292/2024, 1294/2024, 1296/2024, 1298/2024, 1300/2024 to 1304/2024, 1322/2024, 1331/2024 and 1335/2024 to 1343/2024 Vs. State of HP and others decided on 30.04.2024 by the Hon'ble High Court of H.P.

That the above case was listed for final hearing on 30.04.2024 before the Hon'ble High Court of HP when the same was disposed of by way of passing following judgment. Operative part of the judgment is as under: -

2. By way of instant petitions, the petitioners have prayed for grant of following substantive relief:-
"i) That writ mandamus may kindly be issued directing the respondent authorities to consider the petitioner(s) being TGT (Sanskrit) for pay scale of (Arts) and further for State Cadre and for promotion thereto also in view of the judgment passed by this Hon'ble Court in CWP No.2171/2023, titled as Hem Raj v/s State of H.P. & others (Annexure -A)."
3. Learned counsel for the petitioners submits that the case(s) of the petitioners is covered by the judgment passed by this Court in CWP No.2171 of 2023, titled as Hem Raj vs. State of H. P. & Ors, decided on 4th September, 2023, along with connected matters and the instant petitions can be disposed of by directing respondents to decide the case of the petitioners in terms of the aforesaid judgment.
4. Learned counsel for the petitioners submits that petitioners will be content in case the respondents are directed to consider the case of petitioners in time bound manner in light of the judgment passed by this Court in CWP No.2171 of 2023, titled as Hem Raj vs. State of H. P. & Ors, decided on 4th September, 2023, along with connected matters.
5. Accordingly, these petitions are disposed of without making any comments on the merits of the case(s) of petitioners. It is directed that respondents shall consider the case of petitioners in light of judgment passed in CWP No.2171 of 2023, titled as Hem Raj vs. State of H. P. & Ors, decided on 4th September, 2023 within eight weeks from today and will decide the same by passing a speaking order. In case, petitioners are found similarly situated as petitioner(s) in Hem Raj's case (supra), they shall also be granted the same benefits as granted to petitioners in above referred case.
6. Pending miscellaneous application(s), if any, also stand disposed of.

Whereas, the case of the petitioner has been examined in compliance to the judgment passed in CWP No. 2171/2023 titled as Hem Raj vs. State of HP & others taking into consideration the Notification of the Government issued vide No. EDC-B(15)15/2011 dated 20-08-2022 which says, "all Bachelor of Education (B.Ed.) qualified and Teacher Eligibility Test (TET) passed Shastris and Language Teachers(LTs) working in the Elementary Education Department are to be designated as Trained Graduate Teachers (Sanskrit) and Trained Graduate Teachers (Hindi) in their respective pay scale structure."Therefore, no financial benefits were granted to these categories, and merely their nomenclature was changed to TGT (Sanskrit) and
