ORDER

In the matter of: CWP No. 2072/2026 titled as Sanjeev Kumar, TGT (NM) Vs. State of H.P. & others.

Whereas, Sh. Sanjeev Kumar, TGT (NM) presently working in GMS Taggi u/c GSSS Sunara, Distt. Chamba has filed CWP No. 2072/2026 titled as Sanjeev Kumar, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that he may transferred from GMS Taggi u/c GSSS Sunara, Distt. Chamba to one of the stations of his choice in Distt. Chamba. The case of the petitioner was listed before the Hon'ble High Court on 25.02.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

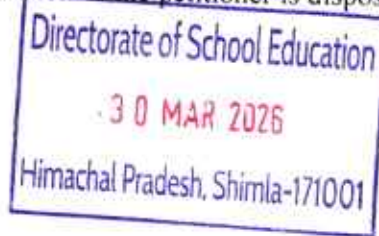
"The petition is accordingly disposed of with the direction that let representation (Annexure P-6) of the petitioner be decided by the Authority concerned sympathetically, within a period of six weeks from today, after affording an opportunity of hearing to the petitioner. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 24.03.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that he may be transferred from GMS Taggi u/c GSSS Sunara, Distt. Chamba to GMS Tritha u/c GSSS Navi-Khad or GMS Kail u/c GSSS Mail Distt. Chamba against vacancy on medical ground.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Taggi u/c GSSS Sunara, Distt. Chamba on regular basis. At present, one post of TGT (NM) is lying vacant at GMS Kail u/c GSSS Mail Distt Chamba.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby transferred from GMS Taggi u/c GSSS Sunara, Distt. Chamba to GMS Kail u/c GSSS Mail Distt. Chamba against vacancy without TTA/JT on medical ground.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
